confident that it's time to build reliable bridges of mutual understanding.

THE EURASIAN PEOPLES' ASSEMBLY THIS IS:

- International Union of the Non-Governmental Organizations and citizens with pro-active approach in life, who share and promote ideas and values of the Eurasian integration, protection of peace, strengthening of friendship, harmony, partnership and good neighborly relations between peoples.
- A platform of equal dialogue between peoples of Greater Eurasia from Lisbon to Vladivostok;
- Institute for the Development of Civil Society and People's Diplomacy, which creates the conditions for the achievement of a new level of knowledge of the peoples of Eurasia, the formation of the consciousness of the Third Millennium Man, who meets the higher level of tasks which all mankind faces with;
- A space of search for the Senses of the future, new directions of development, creation and creativity, mutually beneficial cooperation for the sake of peace on the Earth.

ASSEMBLY'S MAIN GOAL

Formation of the public integration model of the great Eurasian partnership of peoples on the basis of spiritual and moral principles, in the name of peace and harmony, via the development of multilateral cooperation and public (peoples') diplomacy

ASSEMBLY'S MAIN TASKS

- Development of the Eurasian Peoples' Assembly as an important tool of public diplomacy and increasing its role in the terms of formation of multipolar world:
- creation of a large communication platform for interaction of civil society institutions and authorities, unification of people regardless of gender, race, nationality, religion to strengthen the consent and unity of the peoples of Eurasia;
- the unity of the peoples of Eurasia and the upbringing of the younger generation on the basis of basic spiritual and moral values which are common for the whole peoplekind;
- Support of public and state initiatives aimed at preserving peace and harmony, strengthening friendship and interethnic neighborliness;
- unification of efforts for the preservation of the Eurasian continent in all the diversity of its natural, spiritual, cultural, historical heritage and the creation of safe and comfortable living conditions;
- implementation of new interaction formats and the creation of an effective partnership between the Assembly and civil society institutions and authorities of the countries of Eurasia;
- development and implementation of the programmes, projects and events, connected with statutory activities of the Assembly, which are aimed at strengthening of cooperation between peoples of Eurasia;
- creation of opportunities and favorable conditions for exercising resource potential of each person, who is striving to contribute significantly into development of Eurasia.

II. THE FIRST CONGRESS OF THE EURASIAN PEOPLES' ASSEMBLY

May 27-29. Russia. Moscow

The First Congress of the Eurasian Peoples' Assembly was held. More than 2500 representatives from 67 countries took part in it.



More than 40 dialogue platforms were organized within the framework of conference programme, including plenary sessions, round tables, conferences, workshops, forums and themed sessions. More than 130 speakers and moderators took part in discussions and debates, 53 of them are foreign ones. Significant attention was paid at economic cooperation, the interaction of peoples in the fight against terrorism, priorities in the field of ecology, the work of humanitarian missions, cultural cooperation, the development and support of new projects, the prospects for a unified Eurasian information space, the preservation of interethnic harmony and so on.

The solemn ceremony was held within the framework of the Congress: the world public figures were awarded the Eurasian People's Recognition Award "The Ambassador of Friendship".

Cultural programme of the Congress included several interesting events. There were film screenings and meetings with the directors of the first International film festival "Eurasia: Territory of Cinema", gala concert of the Eurasian festival of national cultures "Melodies of Unity", exhibitions "Russia is multinational" and "Eurasia is the continent of peace and harmony", as well as a photo project "Children. Flowers. Life". In addition, the guests of the Congress became participants of the art action "We are for peace on the whole planet," within the framework of which they were invited to leave their mark on the canvas with paint. "Folk" paintings will be donated to the presidents of Russia and Finland.

Within the framework of the Congress of the Eurasian Peoples' Assembly there was a flashmob dedicated to the Day of Eurasian Integration, at which the participants sang the Hymn of Peace by the author Ali Dimayev. The main words of this song are as follows: "the world will be warmed by kindness" were often heard at the congress of representatives of non-governmental organizations of the Eurasian continent, which was held under the motto "Let's make the future of Eurasia together!"

Recognizing the role of civil society and people's diplomacy in developing and strengthening integration on the Eurasian continent, creating a solid foundation for the future of the most densely populated region of the planet, the Congress participants called the creation of the International Union of Non-Governmental Organizations the "Eurasian Peoples 'Assembly " one of the promising forms of implementing the social integration model.

The congress finished its work by forming the General Council of the Assembly and adopting a number of basic documents, including the Final Resolution and the Appeal to the Heads of State and Peoples of Eurasia, as well as to international organizations, in particular the UN and UNESCO, with a proposal to support the initiatives of the Congress.

September 28. Russia. Moscow



The first meeting of the Presidium of the General Council of the Eurasian Peoples' Assembly was held in the Public Chamber of the Russian Federation.

The meeting was chaired by the General Secretary of the Assembly Andrei Yuryevich Belyaninov, with the participation of the Co-Chairs of the

General Council: Igor Vasilevich Khalevinsky, Chairman of the Council of the Association of Russian Diplomats, and Dalbir Singh, President of the Foundation for Political Decisions and Governance (India).

The well-known poet and writer of Kazakhstan, the guest of honor of the event Olzhas Omarovich Suleimenov and the President of the International Association "Peace through Culture. Europe" Wilhelm Augustt agreed to join the Council Of Elders of the Assembly.

November 21. France. Paris



In the Permanent Mission of the Russian Federation to UNESCO, the third extended meeting of the Presidium of the General Council of the Eurasian Peoples' Assembly was held. The meeting was chaired by the General Secretary of the Assembly Andrei Yuryevich Belyaninov. Alexander Igorevich Kuznetsov, Permanent

Representative of the Russian Federation to UNESCO, addressed the audience with a welcoming speech. Having approved the agenda, the members of the Presidium discussed the activities of the Assembly within the framework of the signed agreements, admitted new members, approved the creation of the Eurasian Information Agency and new specialized councils

The second agreement was signed between the Assembly and the International Association of Historians of Asia. On behalf of the Association, the Agreement was signed by the President of the International Association of Historians of Asia Korolev Stanislav Lvovich. The meeting of the Presidium was held at the Russian Center for Science and Culture in Delhi.

April 1, 2018 THE UNITED ARAB EMIRATES

Smirnova Svetlana Konstantinovna, First Deputy Secretary-General - Head of the General Secretariat of the Eurasian Peoples' Assembly reported about the Work Plans of the Eurasian Peoples' Assembly for 2018, 2019 and about the Perspective Plan up to 2022.

Head of the Audit Commission of the Assembly Darnev Svetozar Pavlovich gave particulars about the initiative of formation of the Sponsorship Council within the framework of the Eurasian Peoples' Assembly.

Among the specialized Councils, one more Council, the Council for International Economic Activities, was added. Boris Vladimirovich Olenich, First Deputy Chairman of the Board of the Association "Promotion of the Foreign Economic Activity" was approved as the Chairman of the Council.

The Presidium has also approved changes in the current National Sports Council. Muromsky Alexander Evgenievich, 11-time record holder of the Guinness Book of World Records, President of the Academy of Champions was approved as the Chairman of the Council.





November 23. France. Paris

Bernard Lohse, Co-chairman of the General Council of the Assembly, was the organizer of the event and he spoke on the official part of the event. The



reception was attended by representatives of the public and creative circles, business communities of France and members of the international delegation of the Eurasian People's Assembly.

Svetlana Smirnova, First Deputy General Secretary of the Eurasian People's Assembly, presented the Eurasian People's Assembly to the participants of the meeting and told about the first events of the young organization and about the forthcoming tasks. Bright and interesting was the speech of Prince Alexander Alexandrovich Trubetskoy who touched upon the history of Eurasianism to which his genus is directly related. The evening ended with an excursion around the museum and a creative program in which the guitar, balalaika and accordion sounded delighting and capturing with their sincerity guests from France, Russia, Kazakhstan, Germany, Bulgaria, Austria, Switzerland, and Serbia. Russian folk songs, familiar melodies, gypsy romances did not leave anyone indifferent.

November 24. France. Paris

The Russian delegation of the Eurasian People's Assembly took part in the inauguration of the Russian Forum-2017 which took place at the Embassy of the Russian Federation in France. Alexey Meshkov, the Russian Ambassador to France, addressed the Forum participants.



Svetlana Smirnova, First Deputy Secretary General - Head of the General Secretariat of the Assembly of Peoples of Eurasia Svetlana Smirnova, as an honorary member of the Presidium of the Forum presented the Eurasian People's Assembly created in May this year. Having told about the goals, tasks and the first realized projects Svetlana

Konstantinovna noted that the Eurasian People's Assembly is an International Union of Non-Governmental Organizations and Citizens with an active life position that share and promote the ideas and values of Eurasian integration. Cooperation, commonwealth and harmony are the basis of the Assembly's active efforts to protect peace, strengthen friendship, partnership and good-neighborliness between nations.

VIII. DAYS OF THE EURASIAN PEOPLE'S ASSEMBLY IN INDIA

February 22-23, Delhi, India

On February 22-23, at the invitation of Delhi University, the delegation of the Eurasian Peoples' Assembly took part in the work of the international conference "India and Russia: Cross-Cultural Synergy."

Among the participants of the international conference, there were representatives of science, culture and



education from India, Russia, Georgia, Turkey, Sri Lanka and other countries of the world. The event was timed to coincide with the 70th anniversary of the establishment of diplomatic relations between Russia and India and the 70th anniversary of the establishment of the Russian language department at the Delhi University.

"We have developed relations with a particularly privileged strategic partnership with India. It spans many levels: this is the political level, as well as the level of international cooperation, trade-economic, cultural and others. These special relations cannot develop without knowledge of languages each other," said Russian Ambassador to India Nikolai Kudashev at the opening of the conference.

The main areas of discussion at the conference were international aspects of interaction in the field of literature, the prospects of the Internet as a connecting link of the international community, the issues of the language learning and its role in relations between countries and peoples.

On the sidelines of the conference, members of the delegation carried out a number of working meetings with colleagues from other countries on the issues of participation in the Days of the Eurasian Peoples' Assembly in India from February 26 to March 3, and discussed prospects for further mutual cooperation.

February 26, Delhi, India

A presentation package with materials on the Eurasian Peoples' Assembly, with information on the results of activities for several months from the time of establishment as well as the near-term outlook was presented to Mr. G.V. Srinivas. He commended the Assembly's efforts to establish peace and harmony through the means of people's diplomacy.

February 26, Delhi, India

In the course of the conversation, issues were raised related to the complex environmental situation in many Eurasian

It was noted that the disturbance of harmony between human beings and nature leads to an aggravation of not only environmental but also social problems, which can be solved with the involvement of the civil society potential. In the opinion of the participants, the issue of preserving the natural heritage is extremely important for ensuring sustainable integration processes on the Eurasian continent. At the end of the meeting, both sides recognized the need for close constructive cooperation.

February 26, Delhi, India

The business meeting of the delegation of the Eurasian Peoples' Assembly was held at the Embassy of the Russian Federation in India with the participation of the Ambassador Extraordinary and Plenipotentiary of Russia to India Kudashev Nikolai Rishatovich.

Presenting the main goals and objectives of the visit to India,



Secretary General of the Assembly Andrei Yuryevich Belyaninov noted that the delegation includes people's diplomats from different countries - Russia, France, India, Kyrgyzstan. 

April 2, 2018

Eurasia: Prospects for Business Cooperation" took place, which was attended by representatives of business sector and public organizations from different countries.

The moderators of the roundtable

were: Secretary General of the Eurasian Peoples' Assembly Andrei Belyaninov, Chairman of the High Council of the Association of Universities of Greater Eurasia Mikhail Fedorov, Co-Chairman of the Eurasian Council for Small and Medium Business Svetlana Paraskeva.

Counselor of the Embassy of the Russian Federation in UAE Yuri Vidakas welcomed the participants of the event He emphasized the active start of the Assembly development, which opens the door for enhanced cooperation.

The program of the round table included the following points for discussion:

- Eurasian integration. Greater Eurasia
- The role of the business community in Eurasian integration
- Prospects for business cooperation in the Eurasian space

While opening the round table, Mikhail Fedorov noted the features of the current situation in the field of economics in the countries of Eurasia.

Presentation of the Council for Small and Medium Business of the Eurasian Peoples' Assembly was held. The Chairman of the Council Svetlana Paraskeva described in detail the work of the expert commissions on different areas of business. The Council also presented a number of successfully implemented projects.

One of them is the Eurasian initiative on organization of exchange of best social practices. 
Oftentimes talented young people in the UAE prefer to work rather than receive higher education because of lack of funds. The fund was established to remedy the situation.

X. SPECIALIZED COUNCILS AND PROJECTS

Since the very beginning of the activity of the organization, numerous specialized international councils on the main areas of activity are being actively formed on the platform of the Assembly; there are issues of scientific, economic, cultural cooperation, tasks in the sphere of education, medicine, youth policy in the area of their attention.

Today, on the platform of the Eurasian Peoples' Assembly, 34 specialized councils operates in such areas as international cultural communications, science and education, sports, business, tourism and some others. Dialog of Cultures-2018" and much more are approved and being actively implemented.

July 25 Russia. Altai

In the very heart of Eurasia, in the Gorny Altai Republic, the first meeting of the Council for Spiritual Culture of Eurasian Peoples' Assembly was held. In accordance with the extensive agenda, the members of the Council discussed the results of the First Congress of



Eurasian Peoples' Assembly and the strategic tasks for the further development of the established Assembly. A special attention was paid to on the results of the International Conference "Spiritual Culture - Common Values of Peoples" held within the framework of the Congress, mentioning the relevance of the document adopted at the conference - the Charter of the World's peoples. October 30-31. Russia. Moscow

November 17 Russia.St. Petersburg

The Council of Writers and Readers of the Eurasian Peoples' Assembly held two evenings in St. Petersburg entitled as "100 Years to the Russian Avant-Garde" from the cycle of literary evenings in the countries of Eurasia.

November 18 Russia.St. Petersburg

Banners of the Imperial Family were handed over to the museum preserve "Tsarskoe Selo". The flags were delivered to Russia by efforts of the Council for International Cultural Cooperation of the Eurasian Peoples' Assembly . The ceremony of handing over the banners of the Imperial Family museum preserve "Tsarskoe Selo" was held in St. Petersburg during the Solemn



meeting dedicated to the 110th anniversary of the establishment of the Imperial Russian Military Historical Society. The flags presented are identical to those flags that decorated the streets of Paris in 1896 during the visit of the Russian Emperor Nicholay II. This visit fixed the Russian-French union, the establishment of which took place in 1891-1892, and in 1894 the Convention of the Union was ratified by the Emperor Alexander III, the father of Nicholay II. The yellow flag with the emblem of Russia reproduces the royal banner of the imperial family. The tricoloured flag with the inclusion of the yellow imperial banner with the emblem of Russia reproduces the commemorative maritime flag of the Franco-Russian military alliance.

November 18 Russia. St. Petersburg

The first meeting of the Eurasian Sages' Club took place. The meeting was held within the frames of the 6th International Cultural Forum during the significant days of the 100th anniversary of the October Revolution. The meeting took the form of vivid, interested communication and was devoted to discussing the strategic goals and objectives of the community, the content and schedule of meetings, the forms of interaction and



promotion of the outcomes of the Club's activities.

December 21 Russia. Moscow

The extended meeting with the representatives of the Specialized councils of the Eurasian Peoples' Assembly was held in the Civic Chamber of the Russian Federation. The two main items of the agenda were about the results of the activities of the Assembly and specialized councils for 2017, as well as the work plans of the



Assembly and the Specialized councils for 2018. 22 specialized Councils were established in the Eurasian Peoples' Assembly on various areas of activity, there are issues of scientific, economic, cultural cooperation in the area of their attention. The Chairmen of the specialized Councils shared the first outcomes of the work of the Councils from the time they were created, as well as the plans for the next year, on the basis of which the general perspective plan for the activities of the Assembly was formed. In the Eurasian literary project, writers and readers from more than half of the subjects of the Russian Federation, authors from foreign countries near and far participate. The participants of the congress made their proposals, discussed joint events. Writers from 45 countries of Eurasia are invited at the Third Eurasian Literary Festival of Festivals LiFFt-2018 (Sochi).

15-16 February. Russia. St. Petersburg



With the support and participation of the Arctic Council of the Eurasian Peoples' Assembly, the International Arctic Summit "Arctic and Shelf projects: Prospects, Innovations and Regional Development" was held on the site of the St. Petersburg State Marine Technical University. It was devoted to relevant aspects of the integral development of the Arctic. The summit was organized by the St. Petersburg Arctic

Academy of Sciences. About 300 scientists took part in its work, as well as representatives of science, government and business, more than 100 companies and organizations. The geography of the participants is from Vladivostok and Petropavlovsk-Kamchatsky to the Volga region, Rostov-on-Don and the Arkhangelsk Oblast, from the Nenets and Khanty-Mansiysk autonomous districts to the Republics of Komi and the Sakha (Yakutia), from Japan to France and from Canada and Denmark to Azerbaijan. Within the framework of the "Eurasian" round table, the issues of the integral development of the Arctic Eurasian region through interrelated directions of the economy and the social bloc, and enhancing the competence of the region through the introduction of educational programs for indigenous peoples, regulation of labor resources, development of small and

medium-sized enterprises, including traditional economies of indigenous small-numbered peoples of the North and the Far East.

February. Russia. Moscow

The Council for Eurasian Tourist Safety of the Eurasian Peoples' Assembly held negotiations in the field of tourist safety with the competent representatives of the countries of Eurasia, program of recommendations of visits is launched for countries where the days of the Eurasian Peoples' Assembly were held or planned to be held. List of countries for visiting which security arrangements are drafted: France, India, UAE, Bulgaria, Serbia, Denmark, Switzerland, Italy, Austria.

February, June. Kazakhstan. Astana

Members of the Council on ancestral culture under the leadership of the chairman of the Council N.Dokuchaeva participate in the implementation of the Kazakh-Russian humanitarian project "Mothers's House" - "Ancestral Culture in the prevention of social orphanhood". During the year, studies, consultations, seminars



are being held for specialists of the project "Mothers's House" of the Republic of Kazakhstan for the purpose of preventing social orphanhood. Also in the cities of Russia and Kazakhstan, the International Ancestral Culture School operates on an ongoing basis.

March 6, Russia, Moscow



In accordance with the Charter of the International Union of Non-Governmental Organizations "The Eurasian Peoples' Assembly", at the extended meeting of the Presidium of the General Council on February 27, 2018 in New Delhi, within the framework of the Days of the Eurasian Peoples' Assembly in India, the **Council**

on Business Communications was established and started its work. The main

tasks of the Council on Business Communications is the development of business communications in the relevant areas of the Eurasian Peoples' Assembly activities, organization of cooperation in the interests of supporters of the organization, holding of specialized events, exhibitions, presentations, seminars and other events of national and international level in the countries of Eurasia. On March 6, the first meeting of the Council on Business Communications took place in Moscow. The composition of the Council and the draft work plan for 2018 were approved.

March 6, Russia, Maloyaroslavets

A round table was held here for high school students, public officers, municipal and public organizations, as well as entrepreneurs. In addition to sports, the conversation was about Russian social and cultural

projects for young people. Ekaterina Kaznacheeva, the Chairman of the **Sports Council** of the Euraisan Peoples' Assembly, and Larissa Sheina, executive secretary of the Council participate in the work of the round table. March 27-28. Republic of Belarus. Minsk

Hussein, where in the presence of the First Director of the Youth and Sports Department Aboud Garatli and directors of the office departments it was discussed about the possible interaction on the projects of the Eurasian Peoples' Assembly: Eurasian Equestrian Sports Festival and Eurasiada 2020 и 2021. Particular attention was paid to the priority direction, that is the development of youth sports and creation of a communication platform on the basis of joint sport events.

On April 2, a meeting was arranged with representatives of the management

of ADCOURT company (Sports Marketing and Management) Damir Valeev and Dr Mohamad. Legal, economic and marketing issues of holding the events of the Sports Council of the Eurasian Peoples' Assembly on the territory of UAE were discussed. In total, more than 1200 doctors and specialists in the field of medical

rehabilitation took part in the work of the Congress. In addition, another 850 people in different countries of the world were able to watch online broadcasting of the plenary sessions and lectures. Experts, representatives of major research organizations, medical rehabilitation centers, health resort institutions from Russian regions, as well as representatives of rehabilitation schools from Ukraine, Belarus, Kazakhstan and Armenia took part in the program. Within the framework of the Congress, a meeting of the Specialized council "Eurasia is the Territory of Health" was held on the topic "Achievements and perspectives of the children's rehabilitation development".

April 14. Russia. Astana-Moscow

Members of the Council for Spiritual Culture initiated and carried out a campaign of the book-giving coinciding with the International Book Giving Day. More than 350 books were received at the Headquarter of the Eurasian Peoples' Assembly in Moscow. Some books were sent by the Research

May 14. Russia. Moscow

The event was held via teleconference with the participation of Olympic champions, representatives of

An agreement was reached about supporting this project by the Organizing Committee of FIFA 2018, including by means of posting information about the project on the official portal of the World Championship-Welcome2018. Preparations are being carried out for a number of scientific and methodological conferences on the development of sports education in Russia and countries of Eurasia in 2018, methodological support for a number of educational courses has been developed, negotiations have been held and agreements have been reached with the strategic partners of the Council from Belgium, Spain and Switzerland.

May 19-20. Russia. Moscow



Chairman of the Council for Cossack Integration, ataman of the Union of Cossack Warriors of Russia and Foreign Lands, V.P. Vodolatsky, met with a delegation of veterans of the Second World War from Poland. It was noted that the celebration of the Victory Day is a unifying event for the peoples of Russia and Poland, and that Cossacks also contributed to the

liberation of Europe from fascism. V.P. Vodolatsky supported the proposal of veterans to hold the action "Immortal Regiment" in 2019 in Poland.

May 21. Russia. Moscow

On the basis of the Public Chamber, the 1st congress of the organizers of science and education took The Cooperation place. agreement was signed between the Eurasian Peoples' Assembly and the Association of Education and Science Managers (AESM) with the participation of management representatives of Rosobrnadzor and the RAS. Management representatives



of leading scientific and educational institutions of Russia, as well as of the Eurasian expert community took part in the work of the congress. Among them are Deputy Secretary General of the Eurasian Economic Cooperation Organization Anisiet Gabriel Kochofa, Deputy Head of Rosobrnadzor Muzayev Anzor, First vice president of AMON Dmitry Shkayev and Executive director of the Association Maria Ermilova, as well as vice president, academician of the RAS Alexey Khokhlov. AMON, as well as the **Association of Universities of Greater Eurasia** is aimed at forming a common international educational space on the territory of the continent.

May 29. Tajikistan. Dushanbe

The Sixth International Conference on Interregional Cooperation of Russia and Tajikistan "Interregional cooperation as a factor of growth of Business activity" was held. Yelena Godovykh, Chairman of the Council on **Business Communications** of the Eurasian Peoples' Assembly was the moderator of the roundtable "Main directions for



the Development of Humanitarian and Interregional Relations between Russia and Tajikistan" and presented the projectes of the Assembly.

May 31. Russia. St. Petersburg



International seminar "Arctic public diplomacy in the community of one destiny", organized by the Arctic Council of the Eurasian Peoples' Assembly. the Arctic Academy Sciences, the Center for Social and Political Studies was held with the support of the Alexander Gorchakov Public Diplomacy Fund. The participants of the seminar exchanged views on the

role of public diplomacy in solving problems of Eurasian integration, on the current situation in the Arctic and problems associated with its sustainable development.

June 4-6. Russia. Voronezh

On the base of the business incubator of the Voronezh State Technical University (VSTU) with the support of the Public Organization "Center for Youth Initiatives" and the Eurasian Peoples' Assembly, the All-Russian Forum "Problems and prospects for the development of social entrepreneurship" was held. Experts



from the **Eurasian Council for Small and Medium Business** Nadezhda Kulikova, Vera Plotnikova and Olga Meshcheryakova told the forum participants about the opportunities and prospects for Eurasian integration and the request for youth social projects. A special thematic platform "Activities of the Eurasian Peoples' Assembly in the Development of Small and Medium Businesses and Social Entrepreneurship in Russia and Abroad" was organized within the framework of the forum. The participants discussed the problems and priority directions for the development of social entrepreneurship, talked about the formula for success and innovations.

June 06, 2018, Moscow, Russia



On June 6, at the meeting in Moscow, Alexander Muromsky introduced the new members On the National Sports Council of the Eurasian Peoples' Assembly - Olympic champions Dmitry Trunenkov and Andrei Silnov, repeated world champion Olga Kapranova and the legendary boxer Konstantin Tszyu.

"We held a meeting of the National Sports Council of the Eurasian Peoples'

Assembly, it was attended by 29 unique personalities,- Muromsky said. - We agreed on further development and admission of new members to the Council."

Among the main tasks of the National Sports Council of the Eurasian Peoples' Assembly is the development of sports diplomacy in the Eurasian space, building of mutual understanding and cooperation in the field of national sports and culture for the sake of friendship and mutual understanding of the peoples of Eurasia. Chairman of the Council - Alexander Muromsky, Russian athlete, entrepreneur, charity provider, 11-time record holder of the Guinness Book of World Records.

June 8. Russia. Moscow

There was held a meeting **Chairman of the Sports Council** of the Eurasian Peoples' Assembly Ekaterina Kaznacheeva and Co-chairman of the Sports Council of the Eurasian Peoples' Assembly Diana Al-Shaer with Ambassador Extraordinary and Plenipotentiary of the State of Qatar to the Russian Federation His Excellency Fahad bin Mohammed Al Attiyah.

Agreements were achieved on the joint implementation of international sports projects of the Eurasian Peoples' Assembly - Eurasian competition on Kibatiletika and Equestrian Sports Festival, which are being actively prepared throughout the year. Concepts of events were developed, presentations and negotiations with

representatives of several regions of the Russian Federation were carried out, as



well as negotiations with Qatar and the United Arab Emirates about the holding of the equestrian sport festival on their territory in 2019-2021. The preparatory work was carried out for integration of the project on kibatiletika (sports games for people with disabilities) in other projects of the Sports Council.

June 16. Russia. Moscow

ethnic Council for tourism development of the Eurasian Peoples' Assembly, in the period of the 2018 World Cup finals, carried out the first international festival "Russian Cuisine" on the territory of the cultural and entertainment center "Kremlin in Izmailovo". The festival was designed to attract visitors, mostly foreign guests of the World Cup, to the traditions of Russian



folk culture, popularization of national cuisines of different peoples, folk arts and crafts, popularization of traditional and modern forms of decorative and applied creativity, development and strengthening of friendship and cooperation of peoples of the world.

XI. THEMATIC PROJECTS

In its practical activities, the Eurasian Peoples' Assembly broadly supports international thematic projects. 30 projects are approved, which are being implemented in the form of competitions, festivals, exhibitions, sports competitions, children's educational programs, forums, actions.

November 2. Russia. Orenburg

The final of one of the projects supported by the Eurasian Peoples' Assembly, the First International tourist festival-contest of video, photo and animation "DIVO EURASIA" was successfully held in Orenburg. In total, 212 applications were received, including 32 projects from Eurasian countries. 100 projects were selected for the shortlist, and 50 projects were invited for participation in the final. The final stage of the Festifal has welcomed projects from Russia. Belarus. Kazakhstan, Ukraine, Kyrgyzstan, Serbia, Estonia, Spain.



November 21. France. Paris

The photo exhibition "Weddings of the World's Nations: Cultural Heritage", which was presented in Paris as the project of the Eurasian Peoples' Assembly, aroused a big interest. This creative project was aimed at preserving the ethnic uniqueness of the rituals of creating a family of the peoples of the world. Author of the



project Denis Knyazev, member of the Russian Peoples' Assembly, member of the Russian Geographical Society.

February 27. India. Delhi



The project "Our Global Family" was supplemented with a new video about the charitable foundation Wadah Foundation. The activities of the Foundation on the improvement of the situation of the villagers in Indonesia are devoted to caring for people's health, providing opportunities for women and children to receive education, teaching them their traditional arts. In Delhi, there was held a meeting of members of the delegation of the Eurasian Peoples' Assembly with the author of the project "Our Global Family" - Mary Fisher and representative of the Wadah Foundation.

March 19, Russia, Moscow

In the Public Chamber of the Russian Federation, a working conference of the Eurasian Peoples' Assembly was held, within the framework of which there were carried out meetings of: the organizing committee of the International Festival "Young Arctic", the organizing committee for the preparation and holding of the Days of the Assembly in the United Arab Emirates, the organizing committee of



Emirates, the organizing committee of the Eurasian Festival, of the Festival of Writers and Readers and readers "LIFFt" in Sochi.

March 22-26. Kyrgyzstan. Bishkek

The project "Caravan of Friendship. Road of Life" is being implemented with the support of the Eurasian Peoples' Assembly. The multinational public delegation visited "The Silk Road" in the capital of Kyrgyzstan. Representatives of national communities and national



diasporas of Russia met with deputies of Bishkek city parliament and vice-premier of the Government of Kyrgyzstan. Through the photographic art, the organizers want to remind people of different countries about the spiritual values of love and a strong family that are common for all people.

April 27, 2018, Moscow, Russia



In Moscow, TASS hosted a press conference devoted to the XIV International Festival of Documentary Films and TV Programs "WE WON TOGETHER", which opens on May 15 in Sevastopol with the support of the Eurasian Peoples' Assembly.

May 5. Russia. Moscow

Another photo session of the Eurasian project "Children. Flowers. Life" took place. The heroes were members of the family of the director of the Greek Cultural Center, the candidate of historical sciences and the talented actress - Theodora Yannisi. The photo session was held on the territory and with the support of the official partner of the photo project - the Cultural and

May 15-17. Russia. Moscow

II Eurasian Bread Forum "Bread means peace" was held at the Exhibition of Economic Achievements (VDNKh). Organizers:Russian Guild of Bakers and Confectioners, International Union of Bakers and Confectioners (UIBC), Guild of Bakers and Confectioners of the Eurasian Peoples' Assembly.



The forum included: a large-scale food fair; Salon "Baker and Confectioner", where the whole cycle of production and sale of bakery and confectionery products was visually represented; Festival "Russian Pryanik"; competitions of bakers, including, the XVIII Cup of Russia for Bakery "Bread means peace" and the VII



Cup of Russia for Bakery among Youth "Baker is the profession of the future."

The festival gathered more than 200 participants from 27 countries and 50 regions of Russia. Its sites hosted

The educational program of the festival was realized within the framework of the Eurasian Literary Forum, which included workshops and a series of roundtables on topical issues: "Literary criticism in the context of the contemporary literary process", "Self-promotion of the modern writer", "Aspects of language interaction: translation and publication of poetic texts ". The largest round table "Literary Society: the Future and Present of Literary Associations, Book Publishers and Festivals" brought together authors, critics, publishers, librarians, journalists and book marketing experts from Russia, Germany, Belarus, Austria, Mongolia, Kyrgyzstan, Kazakhstan, Ukraine and other countries of Eurasia. The poet Varis Elchiev from Azerbaijan was awared with the gold medal of the Eurasian Literary Festival.

June 19-23. Republic of Belarus. Minsk


Regional public organization "Council on the Interethnic Cooperation" performed the automobile rally "Caravan of Friendship" Road of Life" to the Republic of Belarus. STATUTE OF THE INTERNATIONAL UNION OF NON-GOVERNMENT ORGANIZATIONS "EURASIAN PEOPLES' ASSEMBLY"

1. GENERAL PROVISIONS

- 1.1. The International Union of Non-Governmental Organizations "Eurasian Peoples' Assembly" (hereinafter referred to as the "Assembly") is a corporate non-profit organization in the organizational and legal form of a "Union" created on the basis of common interests of the Assembly's members to achieve statutory goals.
- 1.2. The Assembly carries out its activities pursuant to the Constitution of the Russian Federation, the Civil Code of the Russian Federation, the Federal Law "On Non-Profit Organizations", other normative legal acts of the Russian Federation, in accordance with universally recognized principles and norms of international law, international treaties of the Russian Federation concerning the activity scope of the Assembly, the current legislation of foreign countries in which there are members of the Assembly or in which territory the branches or representative offices of the Assembly are establishes, and also pursuant to the present Statute.
- 1.3. Full name of the Assembly in Russian: Международный союз неправительственных организаций «Ассамблея народов Евразии».
- 1.4. Short name of the Assembly in Russian: Ассамблея народов Евразии
- 1.5. Full name of the Assembly in English: International Union "Eurasian Peoples' Assembly".
 - 1.6. Short name of the Assembly in English: Eurasian Peoples' Assembly.

- 1.7. The Assembly carries out its activities in the territory of the Russian Federation, as well as in the territories of other states in which members of the Assembly are present or in which territory the branches or representative offices of the Assembly have been established.
- 1.8. Activities of the Assembly are based on the principles of voluntariness, equality of human rights and freedoms, regardless of race, sex, language and religion, including in the matters of organization management, legality, self-government, and is public, and the information on its activities is the public domain information.
- 1.9. The Assembly is a legal entity from the moment of its public registration, has a separate property, has an independent balance, has the right to have a round seal, stamps and forms, settlement and other accounts in rubles and foreign currency in banks of the Russian Federation and abroad.
- 1.10. The Assembly may, in its own name, acquire property and personal non-property rights, bear obligations, to be a plaintiff and defendant in court, in the interests of statutory goals achievement to conduct transactions that comply with the laws of the Russian Federation and the statutory goals of the Assembly.
- 1.11. The Assembly is the owner of its property. Members of the Assembly do not retain property rights to the property transferred by them in the ownership of the Assembly, including admission and membership fees.
- 1.12. The Assembly does not bear responsibility for obligations of its members, and the Assembly members do not bear responsibility for its obligations.
- 1.13. In accordance with the current legislation, the Assembly can create legal entities, as well as acquire property intended for execution of revenue-generating activities. Revenues from the revenue-generating activities cannot be redistributed between members of the Assembly and should be used only to achieve the statutory goals of the Assembly, including for activities related to implementation of its projects and programs. The revenue-generating activities can be carried out by the Assembly only in so far as it ensures achievement of the statutory goals.
- 1.14. The Assembly has a unique corporate style, symbols, (emblem, logo, flag), a hymn, provisions of which are approved by the General Council of the Assembly.
- 1.15. Emblem of the Assembly. The graphic image of the emblem is two equal, symmetrically reflected, symbolizing two wings of blue and yellow forms. Blue is the symbol of Europe. Yellow (golden) color is the symbol of Asia. Intersection of these colors gives a green color a symbol of new beginnings, life-affirming color of nature, characterizing revival and renewal of life, reflecting the unity of man with nature and the whole world.
- 1.16. Logo of the Assembly consists of a graphic part repeating the emblem and the text component (name). The text component of the logo is the abbreviated name of the Assembly in Russian "ACCAMB^E^ HAPOGOB EBPA3HH" or in English "EURASIAN PEOPLES' ASSEMBLY".

The Assembly logo is equally used in Russian and English.

1.17. Flag of the Assembly is an image of the official symbol of the Assembly - the emblem or logo of the Assembly, located in the center of a rectangular white cloth.

The white color of the flag reflects peace and purity. White color is a synthesis of all colors, which symbolizes the unity of the Assembly's members in strengthening the trust and friendship among nations, expanding cultural and humanitarian cooperation, developing peacemaking and Eurasian integration processes.

- 1.18. The Assembly has a hymn, which text is approved by the Presidium of the General Council of the Assembly.
- 1.19. The Assembly has the right to have and use honorary signs and insignia, other signs approved by the Presidium of the General Council and approved in accordance with the procedure established by the law and the present Statute.
- 1.20. The Assembly is free to determine its internal structure, forms and methods of its activities, if this does not violate the current legislation of the Russian Federation and norms of the international law.
 - 1.21. Official languages of the Assembly are Russian and English.
- 1.22. Address (location) of the sole executive body of the Assembly the Secretary General is Russian Federation, Moscow.

2. OBJECTIVES AND SUBJECTS OF ACTIVITY, RIGHTS AND OBLIGATIONS OF THE ASSEMBLY

- 2.1. The main purpose of the Assembly's activity is to unite individuals and legal entities to represent and protect common interests, achieve socially useful goals in the development of integration processes on the Eurasian continent, form a system for a large Eurasian partnership of the Eurasian Peoples' in order to establish peace and consent on the basis of the unified spiritual and moral principles of the Eurasian space through public (people's) diplomacy, culture, science, education and entrepreneurship.
 - 2.2. Subject of the Assembly's activity is as follows:
- 2.2.1. assistance in introduction of new formats for the interaction of non-governmental organizations, civil society institutions, states and members of the Assembly with a view to strengthening the agreement and unity of the Eurasian countries;
- 2.2.2. facilitating the exchange of experience and information among members of the Assembly;
- 2.2.3. creation on the basis of the Assembly of a communication platform on the matters of the Eurasian integration development to coordinate the work of civil society institutions, scientific and educational organizations, business, authorities of all levels and members of the Assembly;
- 2.2.4. assistance in formation of a new conceptual approach to the peacekeeping unity of the Eurasian Peoples' by preserving the unshakable basic spiritual values common to all mankind;

- 2.2.5. support of public, state, peacekeeping initiatives, activities and actions aimed at the peace preservation;
- 2.2.6. introduction of new formats for interaction of the Assembly, other non-governmental organizations and countries of Eurasia;
- 2.2.7. interaction with international organizations and institutions of civil society of foreign states;
- 2.2.8. development and implementation of programs, projects and events (conferences, seminars, competitions, festivals, business games, educational, cultural, sports and other mass events related to the statutory activities of the Assembly), including through the receipt of national and international grants for establishment of humanitarian cooperation among the Eurasian Peoples';
- 2.2.9. making proposals to other non-governmental organizations, governments on various aspects of public life, participating in discussion of draft proposals and decisions;
- 2.2.10. assistance in execution of scientific research and independent expertise, dissemination of objective information, accurate and unbiased information in the field of interethnic and international relations;
- 2.2.11. provision of informational, consultative and methodological assistance to the interested non-governmental organizations in the territory of Eurasian states on issues consistent with the statutory goals of the Assembly;
- 2.2.12. assistance in preservation of the Eurasian continent in all the diversity of its natural, spiritual, cultural, historical treasures, making efforts to create safe and comfortable conditions for the life of all peoples inhabiting Eurasia;
- 2.2.13. development and dissemination of educational, methodological and information materials to assist members of the Assembly;
- 2.2.14. assistance in conducting publishing, broadcasting and other types of public relations activities.
- 2.3. The Assembly has the right, in accordance with the current legislation in force to:
 - 2.3.1. freely disseminate information about its activities;
- 2.3.2. participate in the development of decisions of public authorities and local governments in the manner and scope provided for by the law;
 - 2.3.3. establish mass media and carry out publishing activities;
- 2.3.4. represent and protect its rights, legitimate interests of the members at public authorities, local self-government bodies, non-profit and public organizations;
- 2.3.5. carry out the income-generating activities, foreign economic, educational, publishing activities in the manner prescribed by the law;
- 2.3.6. make proposals to the subjects of the legislative initiative to amend laws and other normative legal acts;
 - 2.3.7. enjoy tax privileges established by the tax legislation;
 - 2.3.8. for the period of its activity, to receive for use the state property;
- 2.3.9. take part in competitions of socially significant projects and programs, in performance of state orders;

- 2.3.10. initiate various issues of public life, to make proposals to the state bodies.
- 2.4. The types of activities that require obtaining of licenses (licensed activities) in accordance with the legislation of the Russian Federation may be carried out by the Assembly upon receipt and availability of a relevant license in accordance with the procedure established by the legislation of the Russian Federation. The Assembly carries out foreign economic activity on the basis of the present Statute and in accordance with the present Statute and the current legislation of the Russian Federation.
 - 2.5. The Assembly is obliged:
- 2.5.1. to observe the legislation of the Russian Federation and other states on which territory the Assembly operates, the generally recognized principles and norms of the international law concerning the scope of its activities, as well as the norms provided for in the Statute and other normative documents;
- 2.5.2. annually to inform the body that made the decision on the state registration of the Assembly to continue its activities with indication of the actual location of the Assembly, permanent acting collegial executive body, its name and data on the managers of the Assembly in the amount of information established by the law;
- 2.5.3. to submit, at the request of the body that adopted the decision on the state registration of the Assembly, decisions of the governing bodies and officials of the Assembly, as well as annual and quarterly reports on its activities in the amount of information established by the law;
- 2.5.4. to provide access for representatives of the body that made the decision on the state registration of the Assembly to the measures taken by the Assembly;
- 2.5.5. to assist representatives of state bodies in acquaintance with the Assembly's activities in connection with achievement of the statutory goals and compliance with the legislation of the Russian Federation.

3. MEMBERSHIP IN THE ASSEMBLY, RIGHTS AND OBLIGATIONS OF THE MEMBERS

- 3.1. Membership in the Assembly is voluntary. Members of the Assembly retain legal, organizational and financial independence.
- 3.2. The members of the Assembly can be fully capable individuals (citizens, stateless persons and foreign citizens legally staying in the territory of the Russian Federation and other states in which there are members of the Assembly or in which territory branches or representative offices of the Assembly are established), and also members of the Assembly may be Russian and foreign legal entities (commercial and non-commercial organizations registered in accordance with the procedure established by the law, which founder and/or member is not the state and its bodies), recognizing the Statute of the Assembly and sharing its goals, participating in the Assembly's activity.

- 3.3. Members of the Assembly have equal rights and bear equal responsibilities in accordance with the Statute, internal documents of the Assembly and the current legislation of the Russian Federation, norms of international law.
- 3.4. Admission to the Assembly of individuals is made on the basis of their personal application for admission to the Assembly by decision of the Presidium of the General Council of the Assembly, adopted by a simple majority.
- 3.5. Admission of legal entities to the Assembly is made on the basis of a decision of the organization authorized body, providing a copy of the Statute and a copy of the Certificate of state registration of this organization. Admission to the Assembly is carried out by a decision of the Presidium of the General Council of the Assembly by a simple majority.
- 3.6. Membership in the Assembly is inalienable. Rights of the Assembly's member can not be transferred to another person.
 - 3.7. Property belonging to members of the Assembly is their property.
 - 3.8. A member of the Assembly has the right:
- 3.8.1. to carry out independent activities and determine its content, have its own statute and program documents that do not contradict the purposes of the Assembly's activities;
- 3.8.2. to participate in development of the main activities of the Assembly, participate in development and implementation of its programs, in all activities of the Assembly;
- 3.8.3. to request and receive information on the Assembly's activities, to receive consultations and information, methodological, legal and practical assistance while implementing decisions of the Assembly's bodies;
- 3.8.4. to disseminate information using the mass media, which founder is the Assembly;
 - 3.8.5. to receive assistance during implementation of international relations;
 - 3.8.6. to elect and be elected to the Assembly's bodies;
 - 3.8.7. to participate in the management of the Assembly's affairs;
- 3.8.8. to receive information on the Assembly's activities and get acquainted with its accounting and other documentation (in cases and in the manner prescribed by the law and the present Statute);
 - 3.8.9. to make proposals for improving the Assembly's business;
- 3.8.10. to appeal decisions of the Assembly's bodies that have civil and legal consequences (in cases and in the manner prescribed by the law);
- 3.8.11. to demand, on behalf of the Assembly, reimbursement of damages caused to the Assembly in cases provided for by the law;
- 3.8.12. to use free services rendered to it on an equal footing with other members of the Assembly;
- 3.8.13. to contest, acting on behalf of the Assembly, transactions on the grounds provided for in Article 174 of the Civil Code of the Russian Federation or the laws on corporations of certain organizational and legal forms, and to demand application of the invalidity consequences, as well as application of the invalidity consequences of nullity transactions of the Assembly;
 - 3.8.14. to join other organizations.

3.9. Member of the Assembly is obliged:

- 3.9.1. timely to pay entrance, membership fees and other property contributions in the amount and in the order established by the General Assembly Eurasian Peoples';
- 3.9.2. to participate in formation of the Assembly's property in the required amount in the manner and within the terms provided for by the Civil Code of the Russian Federation, other laws or the present Statute;
 - 3.9.3. not to disclose confidential information on the Assembly's activities;
- 3.9.4. to comply with the requirements of this Statute and implement decisions of the Assembly's bodies;
- 3.9.5. to participate in adoption of decisions without which the Assembly can not continue its activities in accordance with the law, if the participation is necessary for adoption of such decisions;
- 3.9.6. not to take decisions and not to adopt documents that are contrary to the Assembly's Statute and infringe rights of other members of the Assembly;
- 3.9.7. not to commit acts (inaction) that make it difficult or impossible to achieve goals for which the Assembly was created;
- 3.9.8. to take care of the Assembly's property, not to allow its damage and loss.
- 3.10. Membership in the Assembly can be terminated by the Presidium of the General Council of the Assembly in the following cases:
- liquidation of a member (legal entity) or death of a member (physical person) of the Assembly;
- expulsion of a member from the Assembly for actions contrary to this Statute:
 - voluntary withdrawal from the Assembly's members.
- 3.11. In case of voluntary withdrawal of a member from the Assembly, the member or his authorized body shall notify the Presidium of the General Council of the Assembly on its decision in writing.

4. STRUCTURE OF THE ASSEMBLY'S BODIES

- 4.1. The Assembly's bodies are:
- 4.1.1. The General Meeting of Members (the General Assembly of Eurasian Peoples') is the supreme body;
 - 4.1.2. The Secretary General is the sole executive body;
 - 4.1.3. The General Council is a collegial executive body;
- 4.1.4. Head of the General Secretariat is a person acting without a power of attorney on behalf of the Assembly;
 - 4.1.5. The Audit Commission is a controlling and auditing body.
- 4.2. The supreme body of the Assembly is the General Meeting of the Assembly or, in short, the General Assembly of Eurasian Peoples'.
- 4.2.1. The General Assembly of Eurasian Peoples' is convened by the General Council of the Assembly or the Presidium of the General Council once every four years. The Extraordinary General Assembly of Eurasian Peoples' is convened by decision of the Secretary General, the General Council, the Co-Chairs

of the General Council or the Presidium of the General Council of the Assembly, by decision of the Audit Commission or on a written proposal of at least one third of the Assembly's members.

- 4.2.2. The decision to convene the General Assembly of Eurasian Peoples' (regular or extraordinary) is taken not less than one month before the day of its holding. The decision to convene the General Assembly of Eurasian Peoples' should indicate the date and place of the meeting, draft of the agenda.
- 4.2.3. Members of the Assembly should be informed in writing, including using electronic means of communication and Internet telecommunications network, by the initiator of convocation of the forthcoming General Assembly of Eurasian Peoples' (regular or extraordinary).
- 4.2.4. The order of convening and operation of the General Assembly of Eurasian Peoples' is determined by this Statute and Rules of the General Assembly of Eurasian Peoples', approved by the General Assembly of Eurasian Peoples'.
- 4.2.5. The General Assembly of Eurasian Peoples' is considered eligible if more than half of the Assembly's members are present. Members individuals participate in the work of the General Assembly of Eurasian Peoples' personally. Members legal entities appoint (elect) their representatives to participate in the work of the General Assembly of Eurasian Peoples' and provide protocols to the General Council on appointment (election) of their representatives.
- 4.2.6. Decisions of the General Assembly of Eurasian Peoples' are made by open or closed voting by a simple or qualified majority vote of a number of persons present at the General Assembly of Eurasian Peoples' in the presence of quorum.
- 4.2.7. Decisions on all matters included to the exclusive competence of the General Assembly of Eurasian Peoples' are taken by a qualified majority of two-thirds of the number of persons present in the General Assembly of Eurasian Peoples' in the presence of quorum. Decisions on the remaining issues are taken by a simple majority vote of the number of persons present in the General Assembly of Eurasian Peoples' in the presence of quorum. It is allowed to make decisions at the General Assembly of Eurasian Peoples' by holding an absentee vote (by poll).
- 4.2.8. The General Assembly of Eurasian Peoples' is authorized to resolve any issues related to the Assembly's activities, to ensure that the Assembly respects the purposes for which it was established.

4.2.9. The exclusive competence of the General Assembly of Eurasian Peoples' includes:

- 4.2.9.1. approval of the Assembly's Statute, as well as making changes to it;
- 4.2.9.2. determination of priority directions of the Assembly's activity, principles of formation and use of its property;
- 4.2.9.3. making decisions on the amount and procedure for payment by the Assembly's members of admission, membership fees and other property contributions, including additional property contributions of members to the property of the Assembly;
- 4.2.9.4. determination of the procedure for members admission to the Assembly and expulsion of members from it;

- 4.2.9.5. determination of the number of members and election of members of the General Council of the Assembly for a period of four years and early termination of their powers;
- 4.2.9.6. election by open vote of the Secretary General of the Assembly for the term of four years and early termination of its powers;
- 4.2.9.7. election by open vote of the Head of the General Secretariat for the period of four years and early termination of its powers;
- 4.2.9.8. determination of the number of the Audit Commission members, election and early termination of the powers, appointment of an audit organization or an individual auditor of the Assembly;
- 4.2.9.9. review and approval of reports of the Secretary General, the General Council, the Head of the General Secretariat, the Audit Commission of the Assembly and other bodies of the Assembly;
 - 4.2.9.10. approval of annual reports and accounting (financial) statements;
 - 4.2.9.11. approval of the financial plan and introduction of changes into it;
- 4.2.9.12. approval of Regulations of the General Assembly of Eurasian Peoples';
- 4.2.9.13. making decisions on establishment by the Assembly of other legal entities, on participation of the Assembly in other legal entities, on establishment of branches and on opening of representative offices of the Assembly;
- 4.2.9.14. adoption of decisions on reorganization and liquidation of the Assembly, on appointment of liquidation commission (liquidator), and on approval of the liquidation balance sheet;
- 4.2.9.15. making decisions on the amount of subsidiary liability for obligations of the Assembly;
- 4.2.9.16. other issues proposed for discussion at the General Assembly of Eurasian Peoples' by the Assembly's bodies and members.
- 4.2.10. The General Assembly of Eurasian Peoples' may take any decision without holding a meeting by holding an absentee vote (by poll), except for decisions on matters of the exclusive competence. Such a vote can be conducted by way of documents exchanging by post, telegraph, teletype, telephone, electronic or other communication, which ensures the authenticity of the transmitted and received messages and their documentary confirmation. The procedure for conducting the absentee voting provides for the members of the Assembly to be informed of the proposed agenda, the opportunity to the Assembly's members to familiarize with all the necessary information and materials before the voting, the opportunity to propose additional items to the agenda, and also provides the obligation to inform the Assembly's members before the voting on the amended agenda, and the end date of the voting procedure.

4.3. ASSEMBLY'S SECRETARY GENERAL

4.3.1. The Secretary General is elected by the General Assembly of Eurasian Peoples' for the period of four years and is the sole executive body of the Assembly.

4.3.2. The Secretary General is ex officio a member of the General Council and the Presidium of the General Council, directs their activities and presides at their meetings.

4.3.3. The Secretary General has the following powers:

- 4.3.3.1. exercises overall management of the Assembly's activities and acts on behalf of the Assembly without a power of attorney, has the right of first signature on all documents, issues powers of attorney on behalf of the Assembly;
- 4.3.3.2. directs and coordinates the activities of the General Council, the Presidium of the General Council and the General Secretariat, convenes regular (extraordinary) meetings of the General Assembly of Eurasian Peoples', the General Council, the Presidium of the General Council and presides at such meetings;
- 4.3.3.3. represents the Assembly in all state and non-governmental bodies and organizations; in relations with Russian, international and foreign state and non-state bodies and organizations, public associations, individuals and legal entities, mass media;
- 4.3.3.4. coordinates internal acts regulating the organizational activities of the Assembly as a whole, its separate structural subdivisions and bodies within the framework of the legislation of the Russian Federation and the present Statute;
- 4.3.3.5. signs the minutes of meetings of the General Assembly of Eurasian Peoples', the General Council, the Presidium of the General Council;
- 4.3.3.6. controls the implementation of decisions taken by the General Assembly of Eurasian Peoples', the General Council and the Presidium of the General Council;
- 4.3.3.7. submits for approval of the General Assembly of Eurasian Peoples' a draft of priority areas of activity and drafts of other documents;
- 4.3.3.8. ensures control over implementation of decisions of the General Assembly of Eurasian Peoples', the General Council, the Presidium and other bodies of the Assembly;
- 4.3.3.9. invites the relevant Assembly bodies to nominate candidates for election (appointment) to positions in the Assembly's bodies;
- 4.3.3.10. signs employment contract on behalf of the Assembly with the Head of the General Secretariat of the Assembly;
 - 4.3.3.11. within its competence, issues orders that are binding for execution;
- 4.3.3.12. carries out other activities that contribute to the effective fulfillment by the Assembly of its goals.
- 4.3.4. In the absence of the Secretary General, its duties are performed by the Head of the General Secretariat.
- 4.3.5. Employment contract with the Secretary General on behalf of the Assembly is concluded by one of the Co-Chairs of the General Council on behalf of the General Assembly of Eurasian Peoples'. Terms of the employment contract are agreed by the Presidium of the General Council.
- 4.3.6. The Secretary General is included to the structure of the Assembly's Board of Trustees.

4.4. ASSEMBLY'S GENERAL COUNCIL

- 4.4.1. The General Council is a collegial executive body of the Assembly within the period between the General Assemblies of Eurasian Peoples'.
- 4.4.2. The General Council is elected by the General Assembly of Eurasian Peoples' for the period of four years. The quantitative composition of the General Council is established by the General Assembly of Eurasian Peoples'. The powers of the General Council shall be executed until the election by the General Assembly of Eurasian Peoples' of a new composition of the General Council of the Assembly.
- 4.4.3. The General Council consists of the Secretary General, the First Deputy Secretary General the Head of the General Secretariat, the Chairman of the Board of Trustees.
- 4.4.4. Prominent public figures from Eurasian countries, who have been active for many years, meeting the statutory goals of the Assembly of Eurasian Peoples', can be elected as members of the General Council.
- 4.4.5. Powers of a member(s) of the General Council may be terminated by the General Assembly of Eurasian Peoples' at the request of the General Council in the following cases: voluntary resignation of their powers; termination of membership in the Assembly; violation of provisions of the present Statute, program documents; non-fulfillment of decisions of the Assembly's bodies; commitment of other acts (inactions) that caused or could cause damage to the Assembly.
- 4.4.6. Members of the General Council of the Assembly have the right to participate in the meetings of the Presidium of the General Council, the Audit Commission of the Assembly.
- 4.4.7. The Secretary General of the Assembly manages the activities of the General Council and, in his absence, the Head of the General Secretariat or one of the Co-Chairs of the General Council, on the written request of the Secretary General.
- 4.4.8. Regular (extraordinary) meetings of the General Council are convened by the Secretary General of the Assembly and are held as required, but not less than once a year. An extraordinary meeting of the General Council may be convened by the decision of the Secretary General, the Co-Chairs of the General Council, the Presidium of the General Council on the written request of at least one third of the General Council's members
- 4.4.9. Members of the General Council shall be notified in writing, including by electronic means of communication and the Internet telecommunications network, of the forthcoming meeting of the General Council not later than 30 (thirty) days prior to its holding.
- 4.4.10. Meeting of the General Council of the Assembly shall be considered competent if at least half of the General Council's members are present. Deputy Heads of the General Secretariat, Chairman of the Audit Commission of the Assembly are entitled to attend the meetings of the General Council.

4.4.11. Decisions of the General Council are taken by a simple majority of votes from the number of members of the General Council present at the meeting in the presence of quorum. The form and procedure for voting, including the procedure for secret balloting, are determined by the General Council. The minutes of the meeting of the General Council shall be signed by the Secretary General or other person presiding at the meeting of the General Council and by the Head of the General Secretariat or other person acting as secretary.

4.4.12. The General Council has the following powers:

- 4.4.12.1. ensures achievement of the goals indicated in the Statute, main activities of the Assembly, decisions of the General Assembly of Eurasian Peoples';
- 4.4.12.2. develops drafts of strategic, program and other documents of the Assembly;
- 4.4.12.3. develops recommendations on implementation of the strategic, program documents and provisions of the Assembly;
- 4.4.12.4. interacts within the limits of its competence with state authorities, local self-government bodies, political parties, public associations and other organizations;
- 4.4.12.5. accepts statements on the most important issues of socio-political life, aimed at strengthening the authority and increasing the influence of the Assembly in the international arena;
- 4.4.12.6. establishes and maintains international relations with various non-state non-profit organizations and associations, takes decisions on joining international unions and associations;
- 4.4.12.7. creates relevant Councils on the activities of the Assembly and approves Regulation on the Councils in the areas of activity;
- 4.4.12.8. supervises the implementation of long-term projects in the main areas of the Assembly's activity;
 - 4.4.12.9. reports on its work to the General Assembly of Eurasian Peoples';
- 4.4.12.10. elects the Co-Chairs of the General Council for one year from among the members of the General Council and terminates their powers ahead of schedule:
- 4.4.12.11. on proposal of the Secretary General of the Assembly, determines the number of the Deputy Secretaries General of the Assembly and elects, by open vote from among the members of the General Council, the Deputy Secretaries General, terminates their powers ahead of schedule;
- 4.4.12.12. takes decisions on other issues of the Assembly's activities, except for matters referred by this Statute to the exclusive competence of the General Assembly of Eurasian Peoples'.
- 4.4.13. by decision of the General Council, its certain powers may be delegated to the Presidium of the General Council.

4.5. CO-CHAIRS OF THE GENERAL COUNCIL

4.5.1. The Co-Chairs of the General Council are elected by the General Council by open vote from among the members (no more than 3 persons) for the period of one year. Candidatures are proposed by the members of the General

Council of the Assembly. A member of the General Council of the Assembly can submit his candidacy in the order of self-nomination.

- 4.5.2. Only the members of the General Council of the Assembly from different countries can be elected as Co-Chairs of the General Council.
 - 4.5.3. The Co-Chairs of the General Council have the following powers:
- 4.5.3.1. represent the Assembly in relations with state and non-state bodies and organizations, public associations, individuals and legal entities, mass media;
- 4.5.3.2. preside at meetings of the General Assembly of Eurasian Peoples', the General Council of the Assembly and the Presidium of the General Council of the Assembly;
- 4.5.3.3. convene extraordinary meetings of the General Assembly of Eurasian Peoples', the General Council of the Assembly;
- 4.5.3.4. appeal to the organs and officials of the Assembly, structural divisions of the Assembly with proposals, appeals and statements on the Assembly's activities;
- 4.5.3.5. act on behalf of the Assembly with statements and addresses to state authorities and local self-government bodies, the media and other organizations;
- 4.5.3.6. take decisions on other issues aimed at achieving the statutory goals, not attributed to the exclusive competence of the General Assembly of Eurasian Peoples'.
- 4.5.4. One of the Co-Chairs of the General Council, on the decision of the General Assembly of Eurasian Peoples', signs an employment contract with the Secretary General on behalf of the Assembly.

4.6. PRESIDIUM OF THE GENERAL COUNCIL

- 4.6.1. The Presidium of the General Council is elected by the General Council from among its members by open vote for a term not exceeding the term of office of the General Council's members, members of the Presidium of the General Council.
- 4.6.2. The Presidium of the General Council is accountable to the General Council of the Assembly. The quantitative composition of the Presidium of the General Council is established by the General Council of the Assembly.
- 4.6.3. The Presidium of the General Council consists of the Secretary General of the Assembly, the Co-Chair of the General Council, the Chairman of the Board of Trustees, the Head of the General Secretariat, the Deputy Secretaries General of the Assembly. The Presidium is elected for the term of office of its members. The powers of the Presidium of the General Council shall be executed until election by the General Council of the Assembly of a new composition of the Presidium of the General Council.
- 4.6.4. In case when a member which is elected to the structure of the Presidium of the General Council of the Assembly losses the status of member of the General Council of the Assembly, his powers as a member of the Presidium of the General Council of the Assembly shall be terminated.
- 4.6.5. Meetings of the Presidium of the General Council are held at least once every three months. The meeting of the Presidium of the General Council is considered eligible if more than half of the elected members are present.

- 4.6.6. Meetings of the Presidium of the General Council shall be convened by the Secretary General or by the Head of the General Secretariat.
- 4.6.7. An extraordinary meeting of the Presidium of the General Council may be convened by a decision of the Secretary General, one of the Co-Chairs of the Assembly or at request of at least one third of the members of the Presidium of the General Council.
- 4.6.8. Decisions of the Presidium of the General Council shall be made by open vote by a simple majority of votes from the number of members of the Presidium of the General Council present at the meeting in the presence of quorum.
- 4.6.9. Deputy Heads of the General Secretariat and Chairman of the Audit Commission shall be entitled to participate in the meetings of the Presidium of the General Council.
- 4.6.10. The Presidium of the General Council has the following powers:
- 4.6.10.1. directs the activity of the Assembly in the period between meetings of the General Council;
- 4.6.10.2. develops draft programs of the Assembly and other fundamental strategic, program, organizational and other documents, and develops recommendations for their implementation;
 - 4.6.10.3. accepts applications and statements on behalf of the Assembly;
- 4.6.10.4. takes decisions on convening the General Assembly of Eurasian Peoples';
- 4.6.10.5. represents the Assembly in relations with the public, including the international, with the mass media;
- 4.6.10.6. interacts within the limits of its competence with state authorities, local self-government bodies, political parties, public associations and other organizations;
- 4.6.10.7. establishes and maintains international relations with non-state non-profit organizations and associations, political parties;
- 4.6.10.8. develops and approves instructions, provisions, which approval is referred in the competence of the Presidium of the General Council under the present Statute;
- 4.6.10.9. coordinates the activities of representative offices and branches of the Assembly;
- 4.6.10.10. accepts members of the Assembly and expels them from the members of the Assembly in accordance with the procedure established by this Statute and the Regulation approved by the General Council;
- 4.6.10.11. disposes of the assets and funds of the Assembly within the limits of the approved financial plan of the Assembly;
- 4.6.10.12. makes decisions on approval of transactions carried out by the Assembly, which, in accordance with Art. 27 of the Federal Law of the Russian federation "On Non-Commercial Organizations" entail a conflict of interests between the interested parties and the Assembly;

- 4.6.10.13. makes decisions on approval of transactions (or several interrelated transactions) for the amount exceeding 5,000,000 (five million) rubles;
- 4.6.10.14. makes decisions aimed at attracting additional financial and material resources for implementation of the statutory activities;
- 4.6.10.15. approves the staff list of the Assembly and the limit of staff wages fund of the Assembly, bonus fund of the Assembly;
- 4.6.10.16. ensures fulfillment of the Assembly's responsibilities provided for by the legislation of the Russian Federation;
- 4.6.10.17. makes decisions on awarding of the Assembly's members, employees and other persons, and also applies for state and other awards;
- 4.6.10.18. resolves issues related to accreditation of the Assembly at international organizations;
- 4.6.10.19. hears information on the activities of the General Secretariat of the Assembly with a view to exercising control over the rational use of the Assembly's resources;
- 4.6.10.20. hears reports of the heads on activities of the Assembly's branches and representative offices;
 - 4.6.10.21. approves samples of forms, seals and stamps of the Assembly;
- 4.6.10.22. considers other issues on instructions of the General Council in accordance with this Statute.
- 4.6.11. The Presidium of the General Council has the right to instruct the Head of the General Secretariat of the Assembly to ensure execution of its separate powers.

4.7. GENERAL SECRETARIAT

- 4.7.1. To carry out the current activities of the Assembly, the General Secretariat is being formed, which ensures implementation of the decisions of the General Assembly of Eurasian Peoples', the Secretary General, the General Council and the Presidium of the General Council of the Assembly. The General Secretariat is accountable to the Secretary General of the Assembly.
- 4.7.2. The Head of the General Secretariat manages the work of the General Secretariat. The Head of the General Secretariat is the First Deputy Secretary General of the Assembly.
- 4.7.3. The Head of the General Secretariat is on the position of a member of the General Council, the Presidium of the General Council and the Board of Trustees of the Assembly.
- 4.7.4. The Head of the General Secretariat is elected by the General Assembly of Eurasian Peoples' on the proposal of the Secretary General for the period of four years.
- 4.7.5. Deputy Heads of the General Secretariat are appointed by the Head of the General Secretariat for the period not exceeding the term of his authority and the powers of the Secretary General. Deputy Heads of the General Secretariat act within their competence and are responsible for the scope of activities entrusted to them by the Head of the General Secretariat.
 - 4.7.6. The Head of the General Secretariat has the following powers:

- 4.7.6.1. heads the General Secretariat of the Assembly and manages its activities:
- 4.7.6.2. acts without a power of attorney on behalf of the Assembly and has the right to sign financial documents and other documents referred to the competence of the General Secretariat;
- 4.7.6.3. performs instructions of the Secretary General, ensures implementation of its certain powers and executes them in accordance with the laws of the Russian Federation and the Statute of the Assembly;
- 4.7.6.4. enforces the current policy of the Assembly, as determined by the General Assembly of Eurasian Peoples', the Secretary General, the General Council and the Presidium of the General Council;
- 4.7.6.5. implements the plans, programs and individual activities of the Assembly;
- 4.7.6.6. organizes centralized accounting of members of the Assembly, maintains the Unified Register of the Assembly;
 - 4.7.6.7. organizes accounting of membership fees payment;
- 4.7.6.8. develops, on behalf of the Secretary General, draft provisions provided for by this Statute;
- 4.7.6.9. organizationally provides activities of the Secretary General, the Co-Chairs of the General Council of the Assembly, the General Council, the Presidium of the General Council; the Board of Trustees, the Audit Commission;
- 4.7.6.10. provides preparation of meetings of the General Assembly of Eurasian Peoples', meetings of the General Council and the Presidium of the General Council;
- 4.7.6.11. on instructions of the Presidium of the General Council/Secretary General, develops a draft of the Assembly's financial plan and submits it for approval to the Presidium of the General Council;
- 4.7.6.12. develops draft staff lists of the General Secretariat in accordance with the labor legislation of the Russian Federation, changes the staff list within the limits of the authorized staff and payroll approved by the Presidium of the General Council of the Assembly;
 - 4.7.6.13. provides legal support of the Assembly bodies' activity;
 - 4.7.6.14. organizes training for the Assembly's employees;
- 4.7.6.15. organizes clerical work in the Assembly's bodies, ensures preservation of confidential information;
 - 4.7.6.16. opens and closes settlement and other accounts with banks;
- 4.7.6.17. concludes agreements (deeds, contracts) on behalf of the Assembly, makes transactions on behalf of the Assembly in accordance with the current legislation of the Russian Federation and this Statute;
 - 4.7.6.18. issues powers of attorney on behalf of the Assembly;
- 4.7.6.19. disposes of the property and funds of the Assembly within its competence for transactions (or several related transactions) for an amount not exceeding 5,000,000 (five million) rubles, without approval of the Presidium;
- 4.7.6.20. receives approval of the Presidium for conducting transactions, which, in accordance with Art. 27 of the Federal Law of the Russian Federation

- "On Non-Commercial Organizations" entail a conflict of interests between the interested parties and the Assembly;
- 4.7.6.21. ensures organizational and material-technical activities of the Assembly;
 - 4.7.6.22. ensures conducting the Assembly's events;
- 4.7.6.23. accepts and dismisses the employees of the Assembly, concludes labor contracts with them on behalf of the Assembly in the manner prescribed by the current legislation of the Russian Federation;
 - 4.7.6.24. organizes accounting and statistical reporting;
 - 4.7.6.25. keeps the register of the Assembly's members;
- 4.7.6.26. issues orders and instructions to the employees of the General Secretariat within their authority;
 - 4.7.6.27. approves job descriptions of the General Secretariat's staff;
- 4.7.6.28. exercises other powers entrusted by the General Assembly of Eurasian Peoples', the Secretary General, the Co-Chairs of the General Council, the General Council, the Presidium of the General Council of the Assembly.
- 4.7.7. All employees of the Assembly are appointed (dismissed) in accordance with the Labor Legislation of the Russian Federation only upon concluding an employment contract with them (termination). An employment contract may be concluded for a period not exceeding the term of office of the Assembly's Secretary General or the Chief of the General Secretariat. All employees of the Assembly are covered by the labor legislation of the Russian Federation and laws on social insurance.

4.8. THE BOARD OF TRUSTEES

- 4.8.1. The Board of Trustees of the Assembly acts with the purpose of advising and supporting the Assembly and its other bodies in implementation of their statutory activities.
- 4.8.2. The Board of Trustees of the Assembly is headed by the Chairman of the Board of Trustees, elected by the General Council on proposal of the Secretary General of the Assembly.
- 4.8.3. The Chairman of the Board of Trustees is on the position of a member of the General Council and the Presidium of the General Council of the Assembly.
- 4.8.4. The term of office of the Board of Trustees is four years. The number of members of the Board of Trustees is determined by the General Council.
- 4.8.5. The Board of Trustees consists of credible, respected individuals who have expressed support for the goals for which the Assembly was created.
- 4.8.6. The Board of Trustees of the Assembly is elected by the General Council on recommendation of the Secretary General, the Presidium of the General Council or the Chairman of the Board of Trustees among the well-known figures in the field of science, education, culture, entrepreneurs, heads of public authorities, representatives of the public who have agreed to become its members. Election to the Board of Trustees is possible only with the consent of the invited person.
- 4.8.7. A member of the Board of Trustees may be re-elected an unlimited number of times. Withdrawal from the Board of Trustees is possible on the personal application of the member at any time.

- 4.8.8. The Board of Trustees carries out activities on a voluntary basis. The Assembly has the right to reimburse expenses related to implementation of duties by the members of the Board of Trustees.
- 4.8.9. The Assembly's Board of Trustees consists of the Secretary General of the Assembly and the Head of the General Secretariat.
- 4.8.10. The meeting of the Board of Trustees is eligible if more than half of its members are present. Decisions of the Board of Trustees shall be taken by open vote by a simple majority of votes from the number of those present at the meeting in the presence of quorum.
- 4.8.11. Issues not regulated by this Statute are regulated by the Provisions on the Board of Trustees of the Assembly, approved by the General Council.
 - 4.8.12. The competence of the Board of Trustees includes:
- advising the General Council, the Co-Chairs and the Secretary General on matters of the Assembly's activity;
- advising the Assembly on implementation of its decisions by the Assembly's bodies;
- assistance in finding additional sources of financing for the Assembly and control over the funds use by the Assembly;
- advising the Assembly on the compliance of the Assembly with the legislation of the Russian Federation and the states in which there are members of the Assembly or in which territory branches or representative offices of the Assembly have been established;
- provision of recommendations to the General Council, Co-Chairs, Secretary General on improving the work of the Assembly.

4.9. AUDIT COMMISSION

- 4.9.1. The Audit Commission (hereinafter AC) is the control and audit body of the Assembly. The AC is elected by the General Assembly of Eurasian Peoples'. The term of office of the AC is four years. The AC carries out inspections on behalf of the General Assembly of Eurasian Peoples' and the Secretary General of the financial and economic activities of the Assembly at least once a year.
- 4.9.2. The Assembly's bodies are obliged to provide to the AC all materials, documents and information necessary for conducting inspections. Members of the AC have the right to attend the meetings of the General Assembly of Eurasian Peoples', the General Council and the Presidium of the General Council.
 - 4.9.3. The AC has the following powers:
- 4.9.3.1. controls expenditure of financial resources and other assets of the Assembly;
- 4.9.3.2. controls execution of the Statute provisions, decisions of the General Assembly of Eurasian Peoples' and the General Council by the Assembly's bodies and members:
 - 4.9.3.3. annually informs the General Council about the results of its work;
- 4.9.3.4. exercises other powers on behalf of the General Assembly of Eurasian Peoples', the Secretary General and the General Council.

5. BRANCHES OR REPRESENTATIVE OFFICES OF THE ASSEMBLY

- 5.1. Branches and representative offices can be established by the decision of the General Assembly of Eurasian Peoples'. Branches and representative offices of the Assembly in the territory of the Russian Federation are not legal entities, they operate in the territories of foreign states in accordance with the laws of the country in which the branch is established or the representative office is opened.
- 5.2. Branches and representative offices act on the basis of the Regulations approved by the General Council of the Assembly. Heads of branches and representative offices are appointed by the decision of the Secretary General and act on the basis of a power of attorney issued by the Secretary General of the Assembly.

6. PROPERTY AND SOURCES OF THE ASSEMBLY'S PROPERTY FORMATION

- 6.1. The Assembly may own land plots, buildings, structures, housing stock, transport, communication facilities, equipment, inventory, cultural and educational property, money, shares, other securities and other property necessary for material support of the Assembly, stipulated by this Statute. Property of the Assembly may also include institutions, publishing houses, media, created or acquired at the expense of the Assembly's funds in accordance with the statutory purposes and the current legislation.
- 6.2. Property and assets of the Assembly in accordance with the current legislation are formed on the basis of:
- 6.2.1. entrance, membership fees and other property contributions, including additional property contributions of the Assembly's members;
- 6.2.2. voluntary donations, contributions and receipts from Russian and foreign legal entities and individuals in form of cash, material and cultural values, property;
- 6.2.3. income received from contracts in accordance with the current legislation and this Statute, including performance of works and provision of services;
- 6.2.4. receipts from the Assembly's activities conducted in accordance with this Statute;
 - 6.2.5. profits from income-generating activities;
- 6.2.6. income of business partnerships and societies created by the Assembly or with its participation;
- 6.2.7. receipts from civil-law transactions that do not contradict the current legislation and this Statute;
- 6.2.8. income from activities carried out by other organizations in favor of the Assembly;
 - 6.2.9. bank and other loans;
 - 6.2.10. other proceeds not prohibited by the current legislation.
- 6.3. The Assembly implements the following types of income-generating activities:

- 6.3.1. market research and public opinion research;
- 6.3.2. publication of books;
- 6.3.3. publication of newspapers;
- 6.3.4. other types of publishing activities;
- 6.3.5. provision of social services;
- 6.3.6. scientific research and development in the field of social and human sciences;
- 6.3.7. activities in the field of law;
- 6.3.8. activities in the field of public relations;
- 6.3.9. activities on investigation of public opinion;
- 6.3.10. activity on organization of conferences and exhibitions.
- 6.4. Members of the Assembly do not retain the rights to the property transferred by them to the Assembly, including membership fees and voluntary contributions. In case of withdrawal or exclusion from the members of the Assembly, entrance, membership fees, voluntary contributions are not refundable.
- 6.5. The Assembly's funds can be spent in addition to the objectives of this Statute, to pay for the labor of the Secretary General, Head of the General Secretariat, heads of branches and representative offices of the Assembly, for maintenance of the General Secretariat of the Assembly and other Assembly's staff.
- 6.6. The Assembly is responsible for its obligations by its own means and property, which can be levied under the legislation of the Russian Federation.
- 6.7. The state does not bear responsibility for obligations of the Assembly, nor does the Assembly bear responsibility for obligations of the state. Members of the Assembly bear subsidiary responsibility for obligations of the Assembly in the amount of the approved membership fee. The Assembly is not responsible for obligations of its members.
- 6.8. Owner of the property belonging to the Assembly is the Assembly as a whole. Members of the Assembly do not have the right to own a share of the property belonging to the Assembly, nor does the Assembly own property of its members.
- 6.9. The Assembly may, in respect of property in its ownership or in its proprietary right, perform any transactions that do not contradict the current legislation and this Statute.

7. ORDER OF MAKING CHANGES TO THE ASSEMBLY'S STATUTE

- 7.1. The Assembly's Statute can be changed by the decision of the General Assembly of Eurasian Peoples'. The decision is made by a qualified majority of 2/3 of votes of the present at the General Assembly of Eurasian Peoples' in the presence of quorum.
- 7.2. Amendments to the Statute approved by the General Assembly of Eurasian Peoples' become effective from the moment of their state registration in accordance with the procedure established by the law.
- 7.3. The Assembly's Statute may be amended by a court decision adopted upon application of the Assembly's bodies or a state body authorized to control the

Assembly's activities in the event that keeping the Statute unchanged leads to consequences that could not be foreseen at incorporation of the Assembly, and the General Assembly of Eurasian Peoples' does not change its Statute.

- 8. REORGANIZATION AND LIQUIDATION OF THE ASSEMBLY
- 8.1. The Assembly can be reorganized by way of merger, takeover, division, separation, transformation, and liquidation.
- 8.2. Reorganization of the Assembly is carried out by the decision of the General Assembly of Eurasian Peoples', adopted by a qualified majority of two-thirds of the votes of the present at the General Assembly of Eurasian Peoples' in the presence of quorum. Property of the Assembly after reorganization passes to the newly created legal entities in accordance with the procedure provided for by the Civil Code of the Russian Federation.
- 8.3. The General Assembly of Eurasian Peoples' can make the decision on liquidation of the Assembly. Activities of the Assembly can be terminated also on other grounds in the manner prescribed by the legislation of the Russian Federation.
- 8.4. Property left at the Assembly as a result of the liquidation, after satisfying the claims of creditors, is directed towards achieving the goals stipulated in the Statute of the Assembly.
- 8.5. The decision on liquidation of the Assembly is sent to the body that made the decision on the state registration of the Assembly to exclude it from the Unified State Register of Legal Entities. Liquidation of the Assembly is considered complete, and the Assembly has ceased to exist from the date of registration of the corresponding record in the Unified State Register of Legal Entities.
- 8.6. All documentation of the Assembly after its liquidation is transferred for safekeeping to the State Archives in the manner prescribed by law at the expense and by forces of the Assembly.

RESOLUTION of the Ist Congress of the Eurasian Peoples' Assembly

The 1st Congress of the International Union of Non-Governmental Organizations "Eurasian Peoples' Assembly" was held during May 27-29, 2017 in Moscow.

The decision about establishment of Eurasian Peoples' Assembly and the holding of its 1st Congress was adopted at the 1st Forum of the Peoples of Russia and Eurasia (Moscow, November 2, 2016). The main task of the Assembly was the promotion of unification of the efforts of civil society in the development of integration processes, consolidation of basic universal values, establishment of ideas for peacemaking and the strengthening of goodneighborly relations in the space of "Great Eurasia". The International Organizing Committee of the Congress was formed at the Forum which included representatives of non-governmental organizations from Austria, Armenia, Belarus, Bulgaria, Germany, Israel, Kazakhstan, Kyrgyzstan, Moldova, Russia, Serbia, Tajikistan, Turkmenistan, Turkey, Finland, France and Montenegro.

Over 1,500 representatives of non-governmental (non-profit) organizations, business and intellectual elites from more than 60 countries of the Eurasian continent took part in the work of the 1st Congress. As guests of honor at the Congress were representatives of government bodies from the whole range of states, international organizations, and diplomatic corps and mass media representatives.

At the Congress with welcome address...

Greetings were received ...

During the speeches at the plenary sessions, as well as during over 40 panel discussions, roundtables, conferences and other dialogue venues of the Congress the participants emphasized that the unity of the peoples of the continent is becoming an urgent necessity for the further development of a multi-level integration model - a large Eurasian partnership which is being embodied more and more dynamically at various international and regional levels. A clear indication of this most important trend in the development of modern international relations was the international forum "One belt, one way" held on May 14-15 in Beijing which was designed to promote the creation of a single space of cooperation from the Atlantic to the Pacific. It is noteworthy that among the five most important areas of such cooperation, in addition to the deepening of political cooperation, transport and logistics, trade and financial ties, the need to expand and deepen contacts between people was emphasized.

Agreeing with the Beijing Forum participants the Congress delegates also point out that in order to consolidate international peace, interethnic and inter-confessional dialogue, it is extremely important, along with the activation of mutually beneficial political and trade-economic ties, to intensify cross-border cultural and humanitarian cooperation, to use more widely the potential of people's diplomacy involving into its orbit as many non-governmental organizations and other civil society institutions as possible.

The Eurasian continent, like the whole planet, needs new specific mechanisms to create joint future based on the principles of observance of the norms of international law, justice, equality and mutual respect. One of them, according to deep conviction of the delegates of the Congress should be a multi-faceted peacekeeping interaction of peoples, including interaction in the format of the newly created Eurasian Peoples' Assembly.

The very thesis about the need for broad consolidation of the peoples of Eurasia is not new. A special role in its popularization and substantive filling was played by such structures created at the national level as:

- Assembly of the People of Kyrgyzstan (established by the initiative of national cultural centers at the 1st Kurultay of the people of Kyrgyzstan on 22 January 1994);
- Assembly of the People of Kazakhstan (established on March 1, 1995 in the cadre of realization of the initiative of the President of the country N.A.Nazarbayev, voiced by him at the first Forum of the people of Kazakhstan in October 1992). At present time it is the constitutional body of the Republic of Kazakhstan and is headed directly by the President of the country the author-founder of the idea of Eurasian integration at the present stage;
- The Assembly of the Peoples of Russia (established by representatives of a number of public organizations and the expert community on July 8, 1998 in accordance with the Concept of the state national policy of the Russian Federation approved by the Decree of the President of the Russian Federation from June 15, 1996). At its VI Congress held on July 8, 2013 the Assembly fully supported the initiatives of the Russian President V.V. Putin concerning the further promotion of multi-level integration models in the Eurasian space;
 - Assembly of the Peoples of Moldova (established on March 10, 2010).

In its practical activities the newly created Eurasian Peoples' Assembly will strive to maximally widely accumulate and creatively use the experience of multi-faceted, multi-format work accumulated by the above-mentioned structures, primarily in the sphere of implementing international projects of the most varied orientation. Its priority should be peacemaking, shift of the attention vector from interethnic hatred and hostile relations between peoples who have been good neighbors for centuries, supporting active trade, economic, cultural, humanitarian and purely human contacts, for the establishment of universal human values that guide people to peaceful initiatives, spiritual harmony and international cooperation. The solution of this urgent issue lies in the effective interaction of social mechanisms, institutions and technologies that are really able to transform life together for the better, to transform the renewing countries and peoples of the continent from within, to reveal maximally the creative potential of the peoples of Eurasia.

According to the opinion of the delegates of the Congress, this centuries-old experience of interaction between representatives of different cultures and religions, refuting the "alternative" theories of the apologists about the inevitability of wars and conflicts along the line of so-called civilizational faults, should be taken as the basis of the strategy elaboration of the further development of "Big Eurasia". Another basic principle of the Eurasian paradigm should be the realization that under the conditions of globalization it is the integration processes that can and should become the guarantors of the maintenance of peace, stability and security on a regional and global scale. At the same time, the dynamics of implementation and the viability of these or those integration schemes and models largely depend on harmonious interaction, coordination and complementary efforts of state and non-state factors.

Recognizing the special role of civil society and public diplomacy in developing and consolidating integration on the Eurasian continent, in creating solid foundation for prosperous future for the peoples of the most populous region on the planet, the Congress participants consider the creation of the International Union of Non-Governmental Organizations "Eurasian Peoples' Assembly "as one of the promising forms of implementing the social integration model of large Eurasian partnership.

The Eurasian Peoples' Assembly is open to the widest dialogue and interaction with all those who share the idea of necessity for harmonious interaction, coordination and complementary efforts of state and non-state acts in order to maintain peace, stability and security on a regional and global scale.

Noting the high efficiency and constructive nature of the held discussions, as well as expressing interest in the further development and expansion of the dialogue platforms of the Assembly of the Peoples of Eurasia on a systemic basis, the participants of the First Congress of the Russian Academy of Sciences **DECIDED**:

- 1. To recognize the successful work of the First Congress of the Assembly of Peoples of Eurasia and express gratitude to the members of its International Organizing Committee.
- 2. To entrust the General Council of the Eurasian Peoples' Assembly to formulate a program for the activities of the International Social Movement of the Assembly of the Peoples of Eurasia for 2017-2020 taking into account the received proposals and projects.
- 3. To support the idea of holding an annual Day of Spiritual Harmony, Friendship and Cooperation of the Peoples of Eurasia which should promote the integration processes on the Eurasian continent with its cultural, religious and linguistic diversity and the common desire of the countries and peoples for interaction and good-neighborliness.
- 4. To establish the annual Eurasian Prize of People's Recognition for contribution and consolidation of friendship between nations and the Eurasian integration and to provide its annual delivery. The General Council of the Eurasian Peoples' Assembly shall develop and approve the Regulations of the said prize.
- 5. To approve and send an Appeal to the Peoples and Heads of States, to international organizations (attached).
- 6. To send this Resolution to all state structures and public associations of the countries of the Eurasian continent interested in the development of integration processes as well as to international organizations.

The Congress participants express hope that its decisions will give a new impetus to the development of people's diplomacy and the consolidation of friendship between the peoples of the Eurasian countries.

The participants of the Congress express their gratitude to the bodies of state power and administration, international organizations, business structures, civil society institutions, the mass media of the Eurasian countries for their assistance in its preparation and conduct. Special gratitude goes to the host party, primarily to the Council for the President of the Russian Federation for international relations, the Federation Council and the State Duma of the Federal Assembly of the Russian Federation, the Ministry of Foreign Affairs of the Russian Federation, the Federal Agency for the Commonwealth of Independent States, compatriots living abroad and for international humanitarian cooperation, the Federal Agency for Nationalities Affairs, the Government of Moscow, the Public Chamber of Russia Federation.

APPEAL

Great treasures of world culture were created here, the world's major religions, philosophical and socio-political teachings, recognized throughout the world, arose on Earth. Our common goal is to preserve and develop this cradle of the world civilization.

We believe that the 21st century should be the era of the creation of a peaceful and secure future, the assertion of cultural diversity, interethnic and inter-confessional dialogue, and the development of a new integration model for a large Eurasian partnership from the Atlantic to the Pacific should be based on this foundation.

We are confident that the 21st century is meant to be the century of great and prosperous Eurasia, sustainable and a just world order based on the principles of compliance with international law, justice, mutual respect, wide trade, economic and cultural-humanitarian cooperation designed to ensure the welfare of all countries and peoples of the Eurasian continent.

We strongly believe that the preservation and strengthening of such a fragile peace is a key link in solving the entire set of problems which humanity is currently confronted with. This is the ultimate goal and the basic condition for the survival of civilization. This is the most urgent task for the whole world community today.

The world is suffering from mankind! And now it does not suffer abstractedly, it appeals for urgent real action in its defense.

A global peacekeeping process is necessary, in which national and international non-governmental (non-profit) organizations and other institutions of civil society should play an increasingly active role. relations and give rise to fundamentally new approaches to the self-organization of human being and society.

Today's agenda urgently requires switching attention to the priority solution of such problems as spiritual and moral education and the education of the population, especially the youth; to the statement in the mass consciousness of the principles of a healthy lifestyle; to ensuring progressive socio-economic development and growth of well-being without excessive pressure on the environment; to maximum disclosure of man's resource potential, his intellectual, spiritual and physical perfection.

Guided by the interests of creating a benevolent, constructive Eurasia without wars and conflicts, preserving and consolidating world peace, we, representatives of non-governmental (non-profit) organizations, scientific and creative intelligentsia, business community of more than 60 countries, established the International Union of Non-Governmental Organizations "Eurasian Peoples' Assembly".

Its goal is to become a broad debate platform, not just for discussing the urgent tasks of peacebuilding in Eurasia, but also for determining the priority steps in this direction. And we would like to do these steps together.

In this regard, we appeal to all peoples and heads of states, international intergovernmental and non-governmental organizations with the appeal:

- 1. To unite efforts for the sake of peace and life on Earth.
- 2. To prevent the escalation of the threat of nuclear war.
- 3. To unite efforts in the fight against international terrorism, religious extremism and any other manifestations of a destructive, misanthropic ideology.
- 4. To deploy a broad-based cross-border social movement for peaceful, creative Eurasia.

We express our confidence that only by joint efforts the solution of these tasks is achievable.

We call for the creation of harmonious and benevolent cooperation to unite our efforts and create a happy future.

The Eurasian Peoples' Assembly is open to the wide dialogue and interaction with all those who share the idea of the need for harmonious interaction, coordination and complementary efforts of state and non-state acts in the preservation of peace, stability and security on a regional and global scale.

DECLARATION OF THE ASSEMBLY OF THE PEOPLES OF EUROASIA

The strategic development of the world is in the human resources, the unity of peoples. All of us, regardless of ethnicity, race, nationality, religion, social status, political and ideological convictions, have common goals and aspirations: we want to make every human life stable and worthy, without wars, violence and suffering.

We share a common responsibility for history - for preserving the achievements of our predecessors who we can be proud about; responsibility for the future - for the preservation of moral traditions, the ethnic and cultural identity of our peoples and the transfer of social experience to the following generations.

We consider the diversity of peoples living on our continent as the greatest value. Each of them contributed to the development of Eurasia: science, culture, technical achievements, spiritual knowledge and experience. The creative and cultural potential of the peoples inhabiting Eurasia is the inexhaustible source of development of the Eurasian countries.

Realizing the interdependence of peoples and the common responsibility for the future of the planet Earth,

striving to preserve the unique spiritual heritage of the peoples of Eurasia, respecting the moral ideals and cultural values of each people,

proceeding from the new conceptual approach to the peacekeeping unity of the peoples of Eurasia, from the fact that strategic development today contains in the human resources,

being confident that it's the right time to build reliable bridges of mutual understanding,

WE DECIDED to establish the International Union of Non-Governmental Organizations "Assembly of the Peoples of Eurasia".

ASSEMBLY OF THE PEOPLES OF EURASIA IS THE FOLLOWING:

• The International Union of non-governmental organizations and citizens with an active life position who share and promote the ideas and values of the Eurasian

integration, the protection of peace, the strengthening of friendship, harmony, partnership and good-neighborliness between peoples;

- a platform for equal dialogue among the peoples of Greater Eurasia from Lisbon to Vladivostok;
- Institute for the development of civil society and people's diplomacy which creates the conditions for the achievement of a new level of knowledge of the peoples of Eurasia for the formation of the consciousness of the Third Millennium Man who corresponds to a higher level of tasks facing all mankind;
- Space for searching the Senses of the future, new directions of development, creation and creativity, mutually beneficial cooperation for the sake of peace on the Earth.

MISSION OF THE ASSEMBLY

Formation of the consciousness of the Third Millennium Man creating and approving the mutual creativity of the peoples for the sake of peace and prosperity

THE PRINCIPAL AIM OF THE ASSEMBLY

Formation of the public integration model of the great Eurasian partnership of peoples on the basis of spiritual and moral principles for the sake of peace and harmony through the development of multilateral cooperation and public (popular) diplomacy

THE GENERAL TASKS OF THE ASSEMBLY

- the development of the Assembly of the peoples of Eurasia as an important tool of public diplomacy and enhancing its role in the formation of a multipolar world;
- creation of a broad communication platform for interaction of civil society institutions and authorities, unification of people regardless of their gender, race, nationality, religion in order to strengthen the consent and unity of the peoples of Eurasia;
- the unity of the peoples of Eurasia and the upbringing of the younger generation on the basis of fundamental spiritual and moral values common to all mankind;

THE CHARTER OF THE PEOPLES OF EURASIA

We, the free peoples of Eurasia, for the sake of consolidation of all the people in accordance with the principles of friendship and cooperation, without any distinction made on the basis of race, nationality, religion, social origin, political, mental or ideological opinion, hereby

- Declare our goal to maintain peace among the nations, to preserve the advancements of human civilization, its spiritual, cultural, historical values, as well as our natural resources;
- Agree to apply the moral and ethical rules of peaceful co-existence and friendly relations among different nations.

 For these ends:
- 1. We confirm the spiritual unity of all peoples of the world, regardless of any difference as to our personal opinions or our states' interests, we fully endorse the personal rights and freedoms of all the peoples, including their freedom to religion and belief, languages, traditions, customs, culture, ethnical identity.
- 2. In out activity we are guided by the principles of humanity and non-violence, by our moral duty towards either our ancestors or our descendants. Hence we are advocating that the Culture of Human Values contains the fundamental elements common for all peoples such as: God, love, friendship, respect of the others' persons beliefs, social unity, family, ethics, peace, justice, overall wellbeing.
- 3. Our mission is to preserve the continent and its natural, spiritual, cultural and historical advancements, make all the spheres of life more human-oriented, and hence make Eurasia the common place of living for all the peoples of Eurasia.
- 4. We consider it as a vital point to maintain peace and security by means of International Ethics, for the sake of further promotion of friendly relations among peoples, countries, geopolitical poles.

- 5. We endorse the use of peaceful means of settlement of various disputes; these means should not limit political, social, religious rights and freedoms, as well as the choice of peoples of self-determination and self-identification.
- 6. We condemn the use of aggressive and destructive means, aimed at the suppression of human dignity and the oppression of nations, resulting in the loss of peaceful co-existence.
- 7. Within the framework of activity of the Assembly of the Peoples of Eurasia, we wish to participate in programs for the preservation of life on Earth, to maintain the interests common to all the human-beings, to combine our efforts for the achievement of peaceful and equally favorable conditions for all the people on the Earth.
- 8. Feeling deep anxiety about our future, we are morally obliged to become actively involved in the process of making social peace and ecological well-being, as well as harmonization of international political climate.
- 9. We advocate the ethical ideals and spirituality in life; we respect the right of all nations to the friendship and cooperation.
- 10. Fully taken as the basis of life the harmony of interpersonal relationships, existing on the principles of spiritual harmony of peoples. We wish to create a world community which would abide by the principles of non –violence, without wars, aggression and oppression of political and religious opponents.
- 11. We understand the necessity to unite our efforts to achieve a peaceful and bright future, further evolution of mankind and the necessity of creative civilizational progress.
- 12. We consider that the consolidation of nations and peoples involving the Culture of Human Values, which would bring about the overall stability, is the fundamental mission of the present and future time.
- 13.Being anxious about the situation in the world community, we will strive to assist in promoting peace in the world, the assertion of spiritual braces between the peoples by our driving force of creative change.
- 14. We consider that the universal application of international ethical rules by all the States, regardless of their economical, socio-political situation would promote the progress and well-being of the peoples and nations of Eurasia.
- 15. We shall be aware that culture and spirituality are dependent on our behavior and approach to our lives, to human-beings and community, to the God.

We, the free peoples of Eurasia, are willing to cooperate with all the other nations, with people of different religions, non-governmental institutions and movements for the sake of preservation of peace for the humanization of interpersonal relations.

We are endorsing any initiatives, established by any moving forces, aimed at the preservation of peace and stability, in the context of multipolarism based on common human values. Feeling personal involvement in various processes taking place on the Earth and being responsible for them, let us unite our strength for the sake of prosperity of our planet and social progress of the mankind.

Our firm belief in the prosperous future and our active approach will bring stability to the world and establish a harmonious coexistence of the peoples!
