**REGULATION**  
**on the International Committee «Greater Eurasia - Africa»**  
**of the International Union of Non-governmental Organizations**  
**«Eurasian Peoples' Assembly»**

**I. General Provisions**

1.1. International Committee “Greater Eurasia – Africa” of the International Union of NGOs “Eurasian Peoples’ Assembly” (hereinafter – the Committee) is a special entity of the International Union of NGOs “Eurasian Peoples’ Assembly” (hereinafter – the Eurasian Peoples’ Assembly).

1.2. The Committee was established on the initiative of the Eurasian Peoples’ Assembly members and unites members of the Eurasian Peoples’ Assembly.

1.3. The Committee’s activity is a self-regulating body of the Eurasian Peoples’ Assembly, established and carrying out its work in accordance with the Charter of the Eurasian Peoples’ Assembly and on the basis of this Regulation.

1.4. The decision to establish, reorganize and liquidate the Committee is made by the General Council or the General Council Presidium of the Eurasian Peoples’ Assembly on the basis of the submission of the Eurasian Peoples’ Assembly members who initiated the establishment of the Committee.

1.5. The Committee’s activity is guided by the legislation of the Russian Federation, as well as the legislation of the countries where the Eurasian Peoples’ Assembly operates, the Charter of the Eurasian Peoples’ Assembly, this Regulation and decisions of the governing bodies of the Eurasian Peoples’ Assembly.

1.6. The Committee’s full name is the International Committee “Greater Eurasia - Africa” of the International Union of non-governmental organizations “Eurasian Peoples’ Assembly” and the short name - International Committee “Greater Eurasia – Africa”, what reflects its activities. The name of the Committee

is proposed by the Chairman, Program Director, and members of the Committee and approved by the decision of the General Council or the General Council Presidium of the Eurasian Peoples' Assembly.

1.7. Members of the Committee are free to determine the areas of joint activities that are prescribed in the Regulations on the International Committee "Greater Eurasia – Africa" of the International Union of non-governmental organizations "Eurasian Peoples' Assembly".

## **II. Goals and Subject of Activity**

2.1. The main goal of the Committee is to promote the interests of the Eurasian Peoples' Assembly in the international community on the African continent, to implement the goals and objectives established by the Charter of the Eurasian Peoples' Assembly and other normative acts of the Eurasian Peoples' Assembly.

2.2. In order to achieve the main goal of its activities, the Committee is called upon to solve the following tasks:

2.2.1. Representation of the Eurasian Peoples' Assembly in international organizations of African countries (on a permanent, temporary, or one-time basis);

2.2.2. Representation of the interests of the Eurasian Peoples' Assembly, its regional organizations and divisions at international forums, conferences and other forms of activities that affect the interaction and development of all forms of public diplomacy in Africa;

2.2.3. Involvement of international participants in the discussion of problems and forms of interaction in African countries, studied and implemented by the structures of the Eurasian Peoples' Assembly, as part of the statutory activities of the Eurasian Peoples' Assembly;

2.2.4. Ensuring the preparation of analytical and informational materials of international partners, their joint publication with partner;

2.2.5. Assistance in integrating the Eurasian Peoples' Assembly into international and national public organizations representing the interests of various segments of African societies;

2.2.6. Assistance to the Eurasian Peoples' Assembly in organizing information, presentation, and marketing activities of the Eurasian Peoples' Assembly in Africa;

2.2.7. Increasing awareness in African countries about the activities of the Eurasian Peoples' Assembly as a unifying public organization;

2.2.8. Providing and supporting contacts of the Eurasian Peoples' Assembly with representatives of public, state, business, educational and cultural organizations of African countries;

2.2.9. Organization and provision of international discussion and exchange of views on issues on the world agenda that affect the interests of African countries;

2.2.10. Providing the Eurasian Peoples' Assembly with analytical materials of international publications, research centres, partner organizations on the themes of the Eurasian Peoples' Assembly events.

### **III. Composition and Organization of Work**

3.1. The Committee is formed on the principle of a voluntary membership.

3.2. The Committee includes members of the Eurasian Peoples' Assembly individuals and legal entities who have expressed a desire to work in the Committee in accordance with its tasks defined by this Regulation. The decision to include new members in the Committee is made by the Management Committee based on the application received from the candidate.

3.3. The Committee organizes the Management Committee, which includes the Chairman of the Committee, the Program Director of the Committee.

3.4. The structure of the Committee is formed by Commissions established in certain areas of activity, Heads of Commissions, members of the Committee (representing different countries of Eurasia and Africa).

3.5. The Committee may include individuals - specialists and experts, representatives of non-governmental, state, scientific, educational and public associations of African and Eurasian countries and other continents, legal entities specializing in the activities of the Committee, and members of the Eurasian Peoples' Assembly.

3.6. The Committee may form groups of experts in specific areas, composed of highly qualified professionals.

### **IV. Authority**

4.1. **Chairman of the Committee** - Deputy Secretary General of the Eurasian Peoples' Assembly, represents interests of the Committee activities in Africa and Eurasia in public authorities and management, non-governmental, public, educational, business, cultural and other organizations and unions without a Power of Attorney on behalf of the Eurasian Peoples' Assembly.

#### **Committee Chairman:**

4.1.1. Heads the Committee, organizes its activities, ensures the necessary level of the Committee's activity and the compliance of its work with the goals and objectives of the Charter of the Eurasian Peoples' Assembly.

4.1.2. Forms the Committee and informs the General Secretariat of the Eurasian Peoples' Assembly on the Committee's decisions.

4.1.3. Forms the Committee's work plan for the year and coordinates it with the General Secretariat of the Eurasian Peoples' Assembly.

4.1.4. Forms an annual report on the Committee's activities and sends it to the General Secretariat of the Eurasian Peoples' Assembly no later than December 10 of the current year.

4.1.5. Convenes meetings of the Committee, determines their provisional agenda, date and venue.

4.1.6. Committee Chairman is responsible for compliance with the rules and requirements of this Regulation.

4.1.7. Performs other functions necessary to fulfil the objectives of the Committee and the provisions of this Regulation.

**4.2. Program Director of the Committee** - Deputy Head of the General Secretariat of the Eurasian Peoples' Assembly for International Cooperation:

4.2.1. Performs his activities in accordance with the responsibilities delegated by the Chairman of the Committee.

4.2.2. Chairs a meeting of the Committee in the absence of the Chairman of the Committee.

4.2.3. Form drafts of the work plan and reports on the activities of the Committee and submits them to the Chairman of the Committee for consideration.

4.2.4. Coordinates the implementation of activities in accordance with the approved plan of the Committee activities.

4.2.5. Makes his proposals on programs and projects in order to improve the effectiveness and further development of the Committee.

4.2.6. Performs other functions necessary to perform the tasks of the Committee in accordance with the instructions of the Chairman of the Committee and the governing bodies of the Eurasian Peoples' Assembly.

4.2.7. In the absence of the Committee Chairman, represents the interests of the Committee on issues related to the activities of the Committee in public authorities and management, non-governmental, public, educational, business, cultural and other organizations and unions in Africa and Eurasia.

**4.3. Heads of the Committee's Commissions** are approved from among the members of the Committee in accordance with the approved areas of activity. The Head of the Commission is accountable to the Program Director of the Committee.

4.4. Any member of the Eurasian Peoples' Assembly - a natural or legal person who has the necessary competencies to carry out work in the approved areas of activity or who has authority and recognition in African countries - can become a **member of the Committee**.

## **V. Documents**

5.1. The Committee's documents include:

5.1.1. Regulations on the International Committee “Greater Eurasia – Africa” approved by the General Council or the General Council Presidium of the Eurasian Peoples’ Assembly.

5.1.2. Passport of the Committee, which reflects: name of the Committee; date, month, year of approval of the Committee; goals and objectives; direction and content of activities; full name, position, contact information (phone, email) Chairman of the Committee, Program Director of the Committee and members of the Committee;

5.1.3. Work Plan of the Committee for each calendar year agreed with the General Secretariat of the Eurasian Peoples’ Assembly of;

5.1.4. Minutes of meetings/events of the Committee;

5.1.5. Report on the Committee activities for the calendar year in the form corresponding to the report of the Eurasian Peoples’ Assembly.

## **VI. Symbols**

6.1. The Committee uses the logo and other symbols of the Eurasian Peoples' Assembly in its activities after approval by the General Secretariat of the Eurasian Peoples' Assembly.

## **VII. Responsibility**

7.1. Chairman, Program Director and members of the Committee must comply with the rules and regulations of the Charter of the Eurasian Peoples’ Assembly, this Regulation and the Code of Ethics of the Eurasian People’s Assembly members.

7.2. Chairman of the Committee is responsible for the activities, including the provision of reliable information on the activities.

7.3. In case of non – fulfilment and violation of the provisions of the Charter of the Eurasian Peoples’ Assembly, the Regulations on the International Committee “Greater Eurasia – Africa”, orders of the governing bodies of the Eurasian Peoples’ Assembly, the General Council or the General Council Presidium may terminate the activities of the Committee.

## **VIII. Final Provision**

8.1. This Regulation enters into force upon its approval by the General Council or the General Council Presidium of the Eurasian Peoples’ Assembly.

8.2. If certain provisions hereof come into conflict with the legislation of the Russian Federation and/or the Charter of the Eurasian Peoples’ Assembly, they lose effect and apply the relevant norms of the legislation of the Russian Federation and/or the Charter of the Eurasian Peoples’ Assembly. The invalidity of

certain provisions of these Regulations does not entail the invalidity of other provisions and the Regulations as a whole.

8.3. All changes and additions to these Regulations are approved by the General Council or the General Council Presidium of the Eurasian Peoples' Assembly.
